## 1976 STATE CONVENTION

A majority of the delegates and visitors arrived in Elmira, N.Y. early Wednesday June 23, 1976. A regular business meeting of Elmira Aerie was held at 8 P.M., at which a number of the State leaders and visiting delegates were in attendance. Following this session the Convention Get-Together Party was held also in the home of Elmira Aerie. Dancing and entertainment were enjoyed by all of the early arrivals.

All of the business sessions for the State Aerie's Seventieth Annual Convention were held in the home of Elmira Aerie. The meetings for the State Auxiliary's Twenty Eighth Annual Sessions were held in the Holiday Inn. Registration of delegates opened at 10 A.M. on Thursday June 24, 1976 on the first floor of the Elmira Club.

The State Convention Banquet was held on Saturday evening June 26, 1976 in the main dining room of the Elmira College Campus Center.

### OFFICIAL OPENING OF THE CONVENTION

The convention was opened at 2 P.M. on Thursday June 24, 1976, with State Trustee Wayne Monroe, of Elmira, N.Y. presiding. An overflow crowd of delegates and visitors from both the State Aerie and State Auxiliary filled the meeting hall to capacity. The ceremonies were opened with the presentation of the colors by the Elmira Cadettes. There was a salute to the colors of both the United States and Canada plus the singing of both national anthems. The invocation was given by Captain Fred Marshall, of the Salvation Army. The joint opening session was welcomed by State President Larry Roy and Madam State President Eleanor Schick, who expressed their appreciation for all of the assistance given throughout the year. Elmira President Anthony DiPio, and Madam President Marlene Dominikoski expressed the wish of the local aerie and auxiliary for a most successful convention. The City of Elmira was represented by Mayor John Kennedy, Police Chief Thomas Donnell and Fire Chief David Potter, who all spoke briefly welcoming the delegates and expressing their best wishes for a fruitful convention. Nearby Horseheads was represented by its Police Chief Jesse Schwakhammer, who also spoke. Stan Douglas, Chemung County Legislator, and local radio announcer, spoke on points of interest, as did Carl Draxler, Chemung County Sheriff. Past Grand Madam President Chloe Honeycutt, of Indianapolis, Indiana, welcomed everyone and brought greetings from the Grand Auxiliary. Grand Aerie Auditor Michael T. Gaffeny and Eastern Regional President Harry Woodruff, Grand Aerie representatives, spoke briefly extending their greetings and best wishes for a successful conclave. State President Larry Roy introduced Grand Treasurer Al T. Williams, as the Keynote speaker. Brother Williams gave an excellent address. He elaborated on dedication to ideals particularly those concerning the Fraternity and the understanding of all people. The joint session was brought to a close at 3 P.M. The Auxiliary delegates returned to the Holiday Inn for their first business session. The aerie delegates re-convened for their business session at 3:30 P.M.

### FIRST SESSION

The first session was called to order at 3:35 P.M. by State President Larry Roy.

## **REPORT OF THE JUDICIARY COMMITTEE**

Read by Louis Dion, Chr. Montreal Aerie No. 2130.

### **RULES OF THE CONVENTION:**

Credentials for admission: Properly accredited delegates and Past Worthy Presidents along with Ten Year Secretaries shall obtain their credentials from the proper committee upon presentation of official receipts showing that they are in good standing in their aerie.

No person shall be admitted to the main floor unless he is a delegate, Past Worthy President or Ten Year Secretary. He must display his credentials and deposit the daily attendance slip with the proper aerie officer. A visiting member in good standing, not a delegate, may attend the convention sessions, in a section set aside by the committee, as a spectator only.

A delegate desiring to be heard on any subject, which is properly before the Aerie, shall rise, give the salutation sign, address the Worthy President, state his name and number of his aerie. When recognized by the President he may proceed.

A question indefinitely postponed shall not again be considered, except by the action of two thirds of the delegates voting again to take up the matter.

Voting shall be by the voting sign of the Order, except upon Roll Call, then it shall be aye and nay vote. Any thirty persons may demand a roll call on any question, but such demand shall be made before voting on the question.

Nominating speeches shall be limited to three minutes each and seconding speeches to two minutes each.

The election shall convene in the ante room adjoining the meeting hall on Saturday June 26, 1976 from 9 A.M. to 11 A.M. Only official ballots to be received. The count shall begin promptly at the close of the polls and continue to the completion thereof.

Delegates must present their credentials and ballots, depositing the latter in the ballot box. First ascertaining the number of votes indicated on the credential is identical with that indicated on the ballot and that no erasures appear thereon.

All resolutions must be reduced to writing, typewritten in triplicate if possible, and delivered to the State Secretary for distribution to the proper committees. The Committee on resolutions will, at the proper time, report all resolutions to the convention, with recommendations thereon.

Any part of the issue not covered by the rules of the convention or the rules of order shall be governed by Robert's Rules of Order Revised.

At the conclusion of the reading of the report Brother Dion explained that copies of the Order of Business had been distributed to all delegates making it unnecessary to read the same. ### STATE PRESIDENT'S REPORT

Given by State President Larry Roy, Montreal Aerie No. 2130

Brother Roy gave an extemporaneous report during which he expressed his appreciation for being given the honor of serving as the New York State President which he described as the best experience of his life. He spoke of the many assignments and personal visits he had the pleasure of making during the past twelve months and the splendid welcome that he received on all occasions. He expressed his thanks for the many gifts that had come his way and went into detail about the hundreds of pictures that were taken and are at the present time in his personal scrap book. He spoke about his early years as a member of Montreal Aerie. He stated that he never dreamed of becoming State President, at that time, and it was only the help of all the good brothers that made it all possible. He told of his participation in the "People Helping People" programs for the past twenty years, not only as a member of the Eagles but also as a policeman in Montreal. He informed

all present that he has now retired from the police force and will now devote more time to the programs of the Fraternity. He related how proud he was of the record established by Montreal Aerie and also by the neighboring aerie in St. Jerome. He spoke about being raised in French Canada and he realized that it might have been a little difficult trying to understand his English and he appreciated the fact that everyone was so patient. He spoke at length about the wonderful co-operation he received from all the State leaders he worked with, calling them dedicated people. He elaborated on the assistance given him by State Secretary Lane and the work that he has done for the State throughout the years. He expressed the hope that he will remain as State Secretary for many years to come and will help Owen McNally in the same manner he did for him during the year just passed. In his closing remarks he stated, "as far as he was concerned Canada and the United States are one country." He thanked Elmira for the wonderful hospitality shown and extended his best wishes for a safe trip home to all of the delegates.

### STATE SECRETARY'S REPORT

Read by State Secretary Alfred W. Lane, Tarrytown Aerie 1042.

Brother Delegates:

The fiscal year of 1975 - 1976 was marked with a few disappointments but a great many fine accomplishments that allows us to look back with a great deal of pleasure on the events of the past twelve months. For the first time in the past four years we failed to reach the 3,000 new member mark and also failed to add a new member to the New York State Eagle Family, however, in view of the conditions in various areas throughout the State jurisdiction we did initiate over 2700 new members, almost double the quota set by the Grand Aerie Membership Department and our efforts to date in connection with the Grand Aerie Humanitarian programs equal and in most cases exceed the results of years gone by. The great majority of the programs sponsored by the State Aerie met with great success. All in all the past year will go down in our history books as a progressive era, one that we all can be proud of.

As in the past your State Secretary's Report is an overall review of what has been accomplished during the past twelve months and which will be elaborated on in the reports of the various committee chairmen as the convention progresses.

The State Membership report will show that a great majority of the local aeries made and bettered their quota for the year making possible the overall total of 2705. A fine effort, in view of conditions. Bronx Aerie No. 491 consolidated with Tarrytown Aerie No. 1042 this past winter leaving us with a total of 48 local aeries in the State jurisdiction.

Official per capita tax figures received from the Grand Aerie, as of December 1975, is 16,306. The official figure of the previous year was 14,671, which would indicate that we had a net gain of 1,635 for that period.

Our financial status at the close of the fiscal year came as a pleasant surprise. Despite a few reverses at the very start of the year, the charter plane trip to Dallas being the major set back, we closed out on May 31st with a balance of \$6810.54. The State Secretary's detailed financial report is on the Secretary's desk for inspection, and will be included in the convention proceedings. It is a pleasure, once again, to report that no services had to be curtailed. The same wonderful spirit of co-operation was very much in evidence throughout the entire year and our heartfelt thanks should go to the dedicated State leaders whose presence and support added to so many of our programs and campaigns, and in the majority of cases without any remuneration whatsoever.

Approximately 150 brothers and sisters from the New York jurisdiction traveled to the 77th Annual Grand Aerie Convention, held in Dallas, Texas; 111 flew down in the N.Y. State Charter Plan. Like Texas, the convention was big in every way. Many of the local delegates took a personal part in conducting the business sessions of the convention. We can all be proud of the part that we played in what is known as the Eagle Main Event of the Year.

Our State Fall Conference was held in the beautiful Canadian North Country with St. Jerome Aerie acting as host. Tarrytown, N.Y. was selected as the site for the Spring Conference. Both events were social and business successes. Highlights included awarding the 1977 State Convention to St. Jerome. Selecting Ithaca Aerie as the host for the 1976 Mr. and Mrs. Bowling Tournament and the continuation of the present State Membership Organization with State Secretary Lane as State Director. Lockport, N.Y. was selected as the site of the 1976 State Fall Conference.

As for the Sports Picture during the past year, although we have hundreds of golfers within our midst there was no State Golf Tournament scheduled because of lack of interest. Incidentally, all of the humanitarian committees will be holding a parade of checks later in the convention schedule. During the past year local aeries and auxiliaries from the New York State Jurisdiction were given the honor and pleasure of presenting the following grants: \$5,000 from the Eagles Art Ehrmann Cancer Fund, to Roswell Park Memorial Institute, Buffalo, N.Y. This grant will be presented Saturday evening at the State Convention Banquet. \$1,000 grants from the Jimmy Durante Children's Fund were presented to the following institutions: St. Justine's Children's Hospital, Montreal. Special Children's Ward, Queen Elizabeth Hospital, Toronto, Canada. Special Children's Center, Tompkins County, Ithaca, N.Y. Association for Retarded Children, Al Sigl Center, Rochester, N.Y. Edward J. Keon Memorial School for Retarded Children, Montrose, N.Y. Emma Laing Hospital, Children's Physical

Therapy, Granville, N.Y. Prospect School for Handicapped Children, Glens Falls, N.Y. Wyoming Conference Children's Home, Binghamton, N.Y.

This is what you would call a fast look as to what has been happening to our State Eagle Family during the past twelve months. They were good months because we have learned to work together. A florist would get rich if we were to pass out bouquets to all who made this record possible. ### REPORT OF THE STATE MEMBERSHIP DIRECTOR

Read by State Membership Chr. Alfred Lane, Tarrytown Aerie No. 1042.

Brother Delegates:

After breaking the 3,000 new member barrier for the past three years it came as a little disappointment to a number of our leaders when the overall figure for 1975 - 1976 was announced as 2,705. It wasn't too long ago that we were delighted with a yearly total of 2,500. It is a good sign that we realize we can do better and plans are already in operation to get back in the 3,000 new member class.

As was stated in the State Secretary's report yesterday afternoon "In view of conditions a fine effort was made by the local aeries." Again, this year, 34 of our 48 aeries made and in most cases bettered their annual quota.

We continued with the Zone and District campaign which had proven to be most successful in the past. Our first State-wide program was the Early Bird Campaign in July. The results of the same did not live up to expectations with only 141 new members reported. Watertown Aerie No. 782 with a percentage gain of 5.6% won the Early Bird Trophy and its Worthy President Maurice Helmer Jr. Was the recipient of a \$25.00 Saving Bond. Our Kick-Off Campaign in September got off to a good start with Montreal Aerie No. 2130 leading the way with 34 new members. The State President's Campaign in November saw Montreal reporting 52 more new members to capture the State President's Trophy. Granville Aerie No. 3504, which had been struggling to get back on its feet, came through with a percentage gain of 8.4% to win the November State Membership Department Trophy. St. Jerome Aerie No. 3176, won the Spirit of '76 American Wall Tapestry by securing 35 new members in January to lead the State jurisdiction during that month. During the month of March we held the Old Timers Campaign, honoring the Dean of the Past State Presidents "Bill" Alf, from Buffalo Aerie No. 46. Rochester Aerie No. 52 reported 36 new members to gain the "Bill" Alf Trophy. Rotterdam Aerie with a 12% percentage gain became the recipient of the State Membership Trophy. The Past Presidents campaign in May ended the year with a 270 new member total. Montreal finished with a great big 48 to nip Rochester No. 52 at the wire 322-317 and become N.Y. State Membership Champions for 1975-1976.

As I have stated many times in the past "the greatest plans in the world would go for naught without the support and co-operation of the local aeries." Following is a list of this year's Quota Aeries:

The State Membership Department formulates the plans, the local aerie follows through but the person that completes the picture and makes it all possible is the individual producer who contacts the potential member and in due time makes him part of our fraternity. As an incentive but more as a token of our appreciation for the efforts expended the State Membership Department, each year set up an award program. The Membership Chairman of each Quota Aerie receives a wallet. 34 were awarded. Each member securing five new members in any one month receives an award. 27 pen and pencil sets and 14 Eagle mugs were presented. Each member securing 10 new members during the fiscal year is presented with a handsome traveling clock. 24 clocks were awarded. The following brothers of the Exclusive Twenty Five Club, each received a \$25.00 cash award: Glenn Harper, Hornell; Romeo Bertrand, Montreal; Louis Dion, Montreal; Arthur Richard, Montreal; Virgil Stimson, Oneonta; Alan Barody, Glens Falls; Oliver DeVito, Rotterdam. Romeo Bertrand also received an extra \$25.00 for going over the fifty mark. Top producer for the year is Romeo Bertrand, of Montreal, with a total of 63 new members reported. Runner up is Glenn Harper of Hornell, with 41 new members reported. A \$50 cash award goes to Brother Bertrand and a \$25 award to Brother Harper. Attached to this report will be a complete list of the leading producers for 1975 - 1976. All members of the Exclusive Twenty Five Club and the New York State Big Ten Association will be included.

Each month a small plaque is presented to the aerie securing the greatest number of new members during that period. At the close of the year the New York State Membership Trophy is presented to the aerie with the highest total of new members reported. This year's winner is Montreal No. 2130 with a total of 322. Completing this year's Big Five we have 2-Rochester--317; 3-St. Jerome--270; 4-Elmira--155; 5-Hornell--146.

In the Zone Director's Contest, our newest member Gordon Brenestuhl, of Hoosick Falls Aerie had a record breaking year, finishing with 1214 new brothers in his Zone. Shorty Weber of Lockport Aerie was second with 731. In the District Director's Classic Rene Lessard was all alone with 592 and only two aeries in the District. Harold Fields, of Rochester Aerie was runner-up with 408. Special tribute must go to Elmira's Roz Viele who missed having an all quota zone by just three members. District Directors who had an all quota District are Laurence Campbell, Binghamton; Mason Brunskill, Hornell; Arthur Gonyea, Glens Falls.

We all realize that the above could not have been achieved without your personal help. Our sincere thanks go to one and all. Plans are already in operation for 1976 - 1977. All we ask is your continued help and support. Our program includes monthly class initiations (even if the report contains only one name); a real effort to institute at least two new aeries, plus an all out push to get New York back in the 3,000 new

member category again. If we all take a real interest and work together, this could be the year we will reach 4,000.

Thanks again for all that you have done. It is my sincere wish that your journey home will be a safe one that will lead to a most progressive year ahead.

#### **REPORT OF THE CIVIC AFFAIRS COMMITTEE**

Read by Ralph Pauly, Chr. Olean Aerie No. 616

Brother Delegates:

A lengthy but excellent report was received from Olean Aerie No. 616 about its Civic Affairs Program of the past year. It is as follows: Olean Aerie No. 616 won the distinction of being the first organization in Cattaraugus County to program a public presentation in honor of the Bicentennial. It consisted of an original tableau of nine narrated scenes composed by one of the club members, and made its debut at our Mother's Day function in May 1975 with a cast of 35 men, women and children. Carrying the significant title "Americana". Its theme was to demonstrate how people of diverse nationalities, cultures and religious faiths, pooled their individual abilities and inspirations to bring forth and establish our great nation.

Commencing with a scene of the Pilgrims signing the Mayflower Compact, then proceeding to Colonial times and the Founding Fathers, it carried itself through the waves of immigration in the 1840's and at the turn of the century, plus some memorable events or eras in our Country's makeup. Although, for the most part the show was sprinkled with humor and perhaps a little good natured satire in a couple of places, such as our prohibition days scene, it also had its serious aspects.

The association of the Fraternal Order of Eagles with the founding of

Mother's Day and with the establishment of Boy's Town, two great American institutions, were graphically portrayed. One particularly interesting scene was called "Parade of Personalities", wherein a dozen foreign born individuals were impersonating appropo, each from a different country, who became famous American citizens that left their mark on our way of life.

The scene that had the most emotional impact on the audiences portrayed the famous Four Chaplains of different faiths, as they went down with the USS Dorchester in World War II off the coast of Greenland on February 3, 1943, arms linked together and a prayer on their lips. Not the least item that evoked admiration were the clear improvisations done by our prop committee under the direction of Past Worthy President Richard Lute, together with the exquisite costumes worn in the Colonial scenes created by the ladies of the auxiliary.

As the result of both the Chairman of the local Bicentennial Committee and the Mayor of Olean having been in the audience at its initial presentation, the cast was subsequently invited to perform at the County Fair, then for a program in a neighboring town, which was attended by State Officials and finally to be the feature attraction at the extravaganza in the Olean High School auditorium last November, when Grand Worthy President Joseph Fournier, visited Olean Aerie. An official scroll of acknowledgement was presented by the Cattaraugus County Bicentennial Committee.

Our Home and Family program has also been most rewarding and received with tremendous enthusiasm by the community. Honors are annually awarded at a dinner, to committee selected individuals for outstanding service contributing to the welfare of our city, in the fields of Law and Order, public safety, education and entertainment, as well as civic and charitable endeavor. Awards are also presented to children on various grade levels in the public and parochial schools for exceptional essays on the theme of family and faith.

Presently being looked forward to is the big combined Bicentennial State Beauty Pageant parade on July 5th when our Eagle float, The Founding Fathers, will be rolling down the avenue. As you know the Annual New York State Beauty Pageant is held in Olean, N.Y.

Short reports were received from Fort Hamilton Aerie No. 2621 with relation to its association with the Third Avenue Merchants; Elmont Aerie No. 3128 referring to contributions to the Bravo Volunteer Service; Hoosick Falls Aerie in connection to its donations to all of the village projects.

### **REPORT OF THE SOCIAL SECURITY COMMITTEE**

Read by Mason Brunskill, Hornell Aerie No. 2640.

Brother Delegates:

90% of American workers are now covered by social security. 31 million get monthly social security checks. Today almost all jobs are covered by social security. Disability Insurance was added in 1954 to give protection against loss of earnings due to total disability.

In 1972 legislation was passed so that social security benefits will

automatically increase in the future as the cost of living goes up. However, there are still many who are drawing only minimum benefits and often times are unable to enjoy the bare necessities. A national campaign should be launched to have the congress pass legislation to guarantee these people increases above what they are now getting that would assure them a few extra dollars to enjoy themselves during the latter days of their existence. Also legislation should be inaugurated to improve the benefits and lower the rates of medicare. Under the present plan very few, if any, can afford the extra premiums to pay for additional health insurance which would cover the difference between what medicare pays and the cost of hospital care. Most people living on a fixed income of social security just cannot afford the additional outlay necessary for the protection against sickness and long stays in the hospital.

Legislation has also been recently enacted that enables direct deposit of social security checks in the banks, savings and loans and credit unions. This is not only a time saving process which eliminates having to go to the bank or some other place to cash the check but also eliminates the possibility of theft of the check. This is available to all persons on social security and can be done by merely filling out a simple form authorizing the government to send the check direct to the bank or other saving institutions of your choice. There are many advantages to this arrangement but the main one is peace of mind.

To those who are nearing the age where they will become eligible for benefits under social security, the local social security office has many pamphlets available explaining the details and procedures necessary to apply and also information available for qualifying. They can also help you figure out approximately what your monthly income will be under the plan. Anyone planning to retire should make application for benefits at least three months in advance, so that when they do retire payments will start promptly.

It will be necessary to give them a list of donors from your aerie with their blood type. Also in most communities the Red Cross has a blood program. It is possible for you to set up a certain day or two each month. Join in this program and have a blood bank established in your aerie's name.

Due to the increased demand for blood, especially rare types of blood and so many new discover blood diseases, there is an increasing demand from day to day. Do make an extra effort to get your aerie to join with our other units that are participating.

Your committee has received a report that Olean Aerie has established a blood bank and has blood available for those who are in need.

Middletown Aerie recently completed a successful blood bank campaign which they donated to the Horton Hospital. Other aeries who have had blood donor programs are Fort Hamilton, Rochester, Elmira and Montreal. We feel sure there are many more.

With a little effort on your part we can start some form of program in all of our aeries and truly show that we are people helping people.

The pint of blood that you give today might save a life or be the one that you may need someday.

### REPORT OF THE R.E.A.C. COMMITTEE

Read by Raymond Womble, Chr. Ithaca Aerie No. 1253.

State President Larry Roy, Grand Aerie Representatives,  
State Officers and Brother Delegates:

R.E.A.C. continues to grow in New York State and Eastern Canada and from all reports 1976 - 1977 will be even a greater year.

Not meaning to be repetitious of last year's report which is published in your 1975 State Convention proceedings on page 32, however, I would like to mention a few rules and regulations. It is simple to start a R.E.A.C. Club in your aerie. Write to Retired Eagles Activity Club, National Headquarters, 2401 W. Wisconsin Avenue, Milwaukee, Wisconsin 53233, and ask for an instruction kit. The ground rules for organizing are the same. They require an election of a Chairman, a Vice Chairman, Secretary, Treasurer and Sergeant of Arms. Set a scheduled time for your meetings; either weekly, bi-weekly or monthly. The activities that have met with the most success in organized R.E.A.C.'s are card parties, bingo, dancing, visiting nearby places of interest or other aeries. The main committee of the R.E.A.C. Club should be an active sick and visiting committee.

A number of the clubs open their meetings by having coffee and doughnuts on arrival and then serve a small lunch at noon.

In our reports to date we find that R.E.A.C. in no way interferes with aerie business or in anyway does it conflict with the Senior Citizens organizations in the community. Our members also belong to the Senior Citizens clubs and are active in those organizations also. A number of Senior Citizens have joined the Eagles because they like our programs.

Again, I'd like to remind you that to be a member of the R.E.A.C. you must be 55 years or older, but this does not mean that younger people cannot be part of this program. Most R.E.A.C.'s have social members. By Social we mean a member that is not yet 55 years old but would like to take part in our activities. He is most welcome. A social member has no vote in business meetings but does pay dues, which in most cases is one dollar a year.

Your committee did receive reports from a few of the aeries. Hoosick Falls No. 2467 has an active R.E.A.C. Club which puts on floor shows and works on aerie committees. Montreal Aerie No. 2130, has a newly organized unit which has grown to 86 members and meets monthly in the

aerie home. One of the largest groups organized during the past year is from Toronto Aerie. Its group was instituted with over 100 members. Aerie Secretary Frank Stokes reports much progress is being made and that the members are anxious to contact other clubs and have home and home visits. This is a practice that has been in operation throughout the R.E.A.C. organization for the past couple of years.

Word has been received that Lockport Aerie is making plans to organize this coming year. In due time we believe that nearly 100% of our aeries will have R.E.A.C. Clubs.

Our committee has discovered that a number of aeries that do not have R.E.A.C. Charters, do have some form of get-togethers for their older members but in most cases they are not as active as R.E.A.C. programs are. We feel sure that as time goes by they will adopt our program.

In Judge Hansen, R.E.A.C. has a great booster, but we find that the Grand Aerie Director does not push this program very hard. I would recommend to our Grand Aerie Representatives that at the next meeting of the Board, they call this to the Board's attention and see if we can't get the support for R.E.A.C. that is given to our major fund raising programs. In two years serving as your chairman of the State R.E.A.C. Committee, I have had one letter from headquarters. This was an invitation for us to spend a vacation in Florida.

I am happy that the editor of the Leader and the magazine does give R.E.A.C. publicity and Mrs. Ehrmann certainly gives good writeups about us in Mrs. Eagle.

Your State Committee stands ready at any time to be of help to any aerie that is organizing. Let's hope that our program continues to grow.

This report was given at the State Convention Banquet. A motion was made by Brother Becker that the report be adopted as given. There being no objections it was ruled by the New State President Owen McNally, that the report of the committee was approved.
