# 1979 STATE CONVENTION

As early as Tuesday June 19th a smattering of delegates and visitors started arriving at convention headquarters in the Arena Holiday Inn. Early Wednesday morning the golfing brigade headed for the local links for 18 holes of exercise. The majority of the delegates started arriving right after noon. It is a pleasure to report that the confusion that accompanies the housing of the delegates was at a minimum because of the excellent manner in which the motel personnel handled this phase of the convention. Following the dinner hour there were a number of committee meetings with most of the delegates ending up at the Annual Get-Together party in the home of Binghamton Aerie.

All of the business meetings of both the State Aerie and the State Auxiliary were held in the Holiday Inn. Registration of delegates opened at 10 A.M. in the mezzanine of the Convention Headquarters.

The State Convention Banquet held on Saturday evening June 23rd also was held at the Convention headquarters in the Triple Cities Ballroom.

#### RULES OF THE CONVENTION

Credentials for Admission: Properly accredited delegates and Past Worthy Presidents along with Ten Year Secretaries shall obtain their credentials from the proper committee upon presentation of official receipts showing that they are in good standing in their aerie.

No person shall be admitted to the main floor unless he is a delegate, Past Worthy President or Ten Year Secretary. He must display his credentials and deposit the daily attendance slip with the proper aerie officer. A visiting member in good standing, not a delegate, may attend the convention sessions, in a section set aside by the committee, as a spectator only.

A delegate desiring to be heard on any subject, which is properly before the aerie, shall rise, give the salutation sign, address the Worthy President, state his name and number of his aerie. When recognized by the president he may proceed.

A question indefinitely postponed shall not again be considered except by action of two thirds of the delegates voting again to take up the matter.

Voting shall be by the voting sign of the Order, except upon roll call, then it shall be aye and nay vote. Any thirty persons may demand a roll call on any question, but such demand shall be made before voting on the question.

Nominating speeches shall be limited to three minutes each and seconding speeches to two minutes each.

The election shall convene in the ante room where the Credential Committee is meeting on Saturday June 23, 1979 from 9 A.M. to 11 A.M. Only official ballots to be received. The count shall begin promptly at the close of the polls and continue to the completion thereof.

Delegates must present their credentials and ballots, depositing the latter in the ballot box. First ascertaining the number of votes on the credential is identical with that indicated on the ballot and that no erasures appear thereon.

All resolutions must be reduced in writing, typewritten in triplicate, if possible and delivered to the State Secretary for distribution to the proper committees. The committee on resolutions will, at the proper time, report all resolutions to the convention, with recommendations thereon.

Any part of the issue not covered by the convention rules or the rules of the Order shall be governed by Robert's Rules of Order Revised.

At this time it is customary to read the Order of Business for the Convention, but in view of the fact there is no great change in the procedure, but in view of the fact there is no great change in the procedure, as regard to previous sessions, and copies of the Order of Business have been distributed to all of the delegates, I shall dispense with the reading of the same, if there is no objection. However they will be included in the Convention proceedings.

#### REPORT OF THE MEMORIAL FOUNDATION COMMITTEE

Read by William Carrick, Chr. Middletown Aerie No. 544

Worthy State President, Grand Aerie Representatives, Delegates and Brothers:

Many questions have come up as to the limitations on Medical and Educational benefits payable to the children of Policemen and Firemen killed while on duty, in regards to the Memorial Foundation.

There are no limitations on medical expenses, dental expenses, optical expenses and the cost of prescription drugs except that total hospital, orthodontics and psychiatric treatment is limited to \$5,000 per person. Chiropractic bills are considered medical bills. These medical expenses are paid for eligible children until they reach the age of 18 years, unless they become married or self-supporting at an earlier age.

There is no restriction on the type of school that an eligible child must attend other that it must be an accredited college or university school. These educational benefits are limited to a total of \$5000.00 payable at the rate of \$1,000.00 per year. No benefits are paid to permit eligible children to attend high school. Eligible children may receive educational benefits up to the age of 25 years, unless they become married at an earlier age when benefits discontinue.

We, the committee, hope that we have made the several questions put before us much easier to understand.

# STATE SECRETARY'S REPORT

Read by State Secretary Alfred W. Lane, Tarrytown Aerie No. 1042

Brother Delegates:

It is my pleasure, I can assure you, to be present and to report that once again we have combined our best efforts to make possible another successful year for the New York State Eagle family. As in the past I will touch lightly on our accomplishments, leaving the details to the committee chairmen to elaborate on.

In new membership we didn't exceed the terrific year we had in 1977-1978 but we just missed the 2600 new member mark and we did add another new aerie to the family group. Your efforts in this category made it possible to attain State Bell Ringer status. We continue to have a small number of weak units but no charters were revoked, surrendered or transferred leaving us with a total of 54 local aeries in the State jurisdiction.

Our total number of members, according to the Grand Secretary's office figures is 14,837. Last year our total was 14,848. We just missed by 11 members becoming a Net Gain State Aerie. Again I must point out that the figures of the aeries reporting after the survey was taken were not counted.

Along with the rest of the country we are feeling the financial crunch. Our balance as of May 31, 1979 was \$4,239.16. This figure is \$1,232.09 below the balance of one year ago. The State Secretary's financial report is on the Secretary's desk for inspection and will be included in the Convention proceedings. As in the past we did manage to continue all of our services. Although our State Per Capita tax was increased for the past six months, keeping within the present boundries was only made possible because so many of our State and local leaders gave their support to all of our programs and campaigns, in the majority of cases without any renumeration whatsoever.

A nice delegation from the local aeries and auxiliaries traveled to Spokane, Washington, for the Grand Aerie Convention. A majority took a part in the business sessions and practically all of the "New Yorkers" were in the Convention parade. Quite a few of our boys and girls were appointed as Eastern Regional Representatives for the various Humanitarian Funds. Highlighting the convention, as far as the New Yorkers were concerned was the appointment of Carmelita Pauly, of Olean Auxiliary, as Eastern Regional President and the nomination and election of Owen McNally, Fort Hamilton Aerie, as Grand Inside Guard.

Our Fall and Spring Conferences held during the past year in Depew and Middletown, respectively, more than lived up to expectations. Highlights included selecting Rochester as the site of the 1980 State Convention. Selecting Captain Allen Leidy and Fireman Frank Pingotti, both from Middletown, N.Y. for the Firemen of the Year Award. Laverne "Shorty" Weber was reappointed as State Membership Director for 1979-1980. The 1979 State Mr. and Mrs. Bowling Tournament went to Tonawanda Aerie and Endicott was selected as the site for the State Fall Conference in September.

Bowling is our only sport as far as Statewide activity is concerned. The Mr. and Mrs. Bowling Tournament held in Hornell, last Fall, was another Eagle success. Excellent alleys and high scores made most of the bowlers very happy at the Annual State Bowling Tournament, held this year in Glens Falls, N.Y. We know that Delmar "Kit" Carson, of Hornell, will never forget it as he rolled the only 300 game in the 32 year history of the tournament. We still have hopes of having a Statewide Golf Tournament and perhaps a Softball tournament, as well, in the near future.

Our aeries and auxiliaries continue to donate generously to all of our Humanitarian Funds. A parade of checks for each fund will be held later in the convention schedule. Again, this year New York State has been given the honor and privilege of presenting a number of grants from the various funds to deserving institutions throughout the State jurisdiction. I am sure the particulars will be included in the reports to follow.

As we look back on another wonderful year, we again see demonstrated that personal efforts and our ability to work as a team made it all possible. It is impossible to point out all of the unsung heros and heroines that played such a big part in making this all happen but special thanks should go to the State Officers, the State Membership Group, State President Art Cichon and my long time buddy State Treasurer Ken Decker. To all of the local aerie secretaries my sincere thanks for your co-operation.

Looking ahead to 1979-1980, all signs point to a banner year. We already have one new aerie, just recently instituted in Mechanicville and many more potential sites, whose surveys have been approved and whose organizers are hard at work to turn them into progressive aeries. State Membership Director "Shorty" Weber has a number of ideas that he would like to put into operation. All we need is your continued support to keep New York as one of the better State Aeries in the Eagle jurisdiction.

This little get together has all the earmarks of being one of our better conventions. It is the wish of all concerned that your journey back home will be without incident. Again, my sincere thanks to each and everyone of you.

# BROTHER EAGLES:

Although we had hoped for a banner year in new members we fell short of the total reported last year and short of our goal set last June. We did however add 2580 new members and instituted a new Aerie in Canajoharie. I am happy to report the baby is healthy and growing stronger each day. The happy note came when we learned New York State Aerie did become a Bell Ringer.

We started off with a steady pace during June, July and August adding 443 to our rolls by the end of August. The September Kick Off Campaign added another 252. The Hunters Campaign in November was a little disappointing but added another 188.

The Hunters Trophy went to Elmira #941 for reporting 30 new members. The State Membership Trophy to Mississauga #3806 with a percentage gain of 15% by

reporting 15. December exceeded expectations when a whopping 237 were reported. A disappointing January brought in 201 members and the State President's Trophy was captured by our brothers from St. Jerome when they came through with 20 new members. Flushing Aerie with a percentage gain of 8% became the recipient of the State Membership Trophy. The under Thirty Five Campaign during March was by far our best when 351 were reported. Depew-Lancaster Aerie #2692 took the State Membership Trophy by reporting 53 new members and Shawinigan #3810, one of the new members of our Eagle family, reported 39 and captured the Percentage Gain Trophy with a 48% gain. Shawinigan again took the honors in April in the Old Timers Campaign by reporting 17 for a percentage gain of 20% and took home the "AL LANE TRAVELING LOVING CUP" held by Endicott Aerie for the past year. Again this year every effort was made to have all Aeries report at least one new member each month. Although we did not achieve this, forty nine out of fifty four Aeries did report new members during the year and 38 Aeries joined the quota group with many of them making their quota several times over. Special congratulations to the leaders of Zone one for the publication of an outstanding Zone Bulletin and for a Zone family picnic, which has tripled in attendance over the past three years, as their summer meeting. Gordon Brenenstuhl again receives the honor for being top Zone Director with a total of 918 new members and Richard "Caker" Updike became top District Director for the year with 445 new members.

Our friendly 3 to 1 membership contest with the Auxillary turned out disastrous with the gals easily walking all over us. State President Cichon predicted from the beginning the odds were too high. Nevertheless he and I will take our medicine and give the ladies their well deserved day.

My sincere thanks to all of you for making my first year as your State Membership Director an enjoyable and productive experience. As time marches on experience is gained and plans again are underway for a bigger and better year ahead. We all learn from our mistakes. At our membership meeting at 4:00 o'clock this afternoon all interested brothers are invited to take part in discussing plans and ideas for our yearly membership campaign. As the old saying goes "We did it before and we can do it again."

Once again my sincere thanks to all. Without your efforts and contributions our fraternal family could not have added 2580 new members. May God bless you all and with his help, may you all have a safe journey home at the close of this Convention.

Following a few congratulatory remarks in relation to the fine record being made by the New York State Aeries Brother Gaffney elaborated on the importance of abiding by the rules and regulations, centering his remarks on the duties of the local aerie officers particularly on those relating to the aerie trustees. It was a constructive and inspiring talk which brought a standing ovation from the delegates.

Brother Lane spoke briefly, expressing his thanks and appreciation on receiving the Eagle Publication award. He stated he was delighted that Brother Gaffney was selected to make the presentation, as both he and Mike have been closely related to Eagle Programs since 1942. He gave a short resume of the fine membership record made by Brother Gaffney, in the State of New York, in years gone by, and gave full credit to him for the splendid State Organization that we all enjoy today.

# FIRST REPORT OF THE RESOLUTIONS COMMITTEE

#### **RESOLUTION NO. 1**

Read by Frank Stokes, Chr. Toronto Aerie No. 2311

WHEREAS: The Fraternal Order of Eagles has designated itself as an International Organization, having established units in the United States of America, Canada, Mexico, Phillipine Islands and in the United Kingdom of Great Britain, and

WHEREAS: Certain parts of the ritual of the Order, more specifically the exemplification of Liberty, in the initiatory ceremony, is preponderantly flavoured

with American history and American patriots only, and

WHEREAS: in the solicitation of prospective members for the Order, the latter are given to understand that the Fraternal Order of Eagles is in fact international in its scope, and

WHEREAS: candidates standing before the aforesaid station of Liberty are impressed by both the wording and transparency that the Order is "American" oriented rather than "International", and

THEREFORE BE IT RESOLVED: that steps be taken by the Grand Aerie to make the necessary amendments in the wording of the Junior Past Worthy President's charge of the ritual so as to eliminate the reference to American History and American patriots and also to re-illustrate the transparency depicting the principle of Liberty without exposing the flag of any country whatsoever, and

BE IT FURTHER RESOLVED: that a copy of this resolution be referred to the Grand Aerie of the Fraternal Order of Eagles for consideration at its forthcoming annual Convention in Kansas City, Missouri.

Adopted by the members of Maple Leaf Aerie No. 2311, Toronto, Canada, at its regular meeting held on June 11, 1979.

Before any action was taken Brother Stokes informed the delegates that a similar resolution was prepared and forwarded to the Grand Aerie in 1976 and it became lost. That is our reason for submitting this same resolution in 1979. Brother Stokes than read the following which is in relation to the initiatory ceremony of the Fraternal Order of Eagles.

The initiatory ceremony of the Fraternal Order of Eagles is written to reflect the basic principles of the Order - Liberty, Truth, Justice and Equality. It was written when the Eagles had established aeries in communities in the United States and Canada.

In the course of time, the Order established a unit in the city of Manila in the Philippine Islands and then more recently in Mexico and the United Kingdom of Great Britain. As the Order expanded beyond the continental borders of the United States it has become recognized as an "International" organization.

Presumably, it is the policy or intent of the leaders of the Fraternal Order of Eagles to further expand the Eagles' wings to additional communities in those countries in which units have recently been established and possible in other countries as well.

With the foregoing in mind, it is believed by many that consideration should be given by our leaders for a review of the Order's Initiatory ceremony, more particularly to the Station of the Junior Past Worthy President from which the principle of Liberty is exemplified.

It must be admitted that both the transparency and the wording of the charge itself is "American" oriented, rather than "international". The picture depicting Liberty is draped with the American Flag while there are references in the charge to American heroes and patriots who were prominent in the struggle for liberty and freedom in the early years of American history. Furthermore, it is believed that

other references in the charge do not clearly interpret the meaning of the word "liberty" to the average layman joining the Order or his concepts of "liberty" as is presently understood in this day and age.

While the "Stars and Stripes" is truly the symbol of liberty to the patriotic citizens of the United States, the flag of Canada is also the symbol of Liberty to Canadians, as is the flag of the Philippine Islands to the Filipinos, the flag of Mexico to the Mexicans and the Union Jack to Britons. It would be more in keeping with the international nature of the organization were the "Stars and Stripes" replaced by a common symbol to portray the theme of liberty.

It has actually been a fact that some members in joining the Order and taking the initiatory ceremony are surprised (and sometimes resentful) in seeing and hearing an American dominated theme at the Station of Liberty to portray that principle, when they were given to understand in signing the application for membership that they were becoming associated with an "international" organization. It is believed that there has been no criticism in the charges exemplifying the concepts of Truth, Justice and Equality.

While the author of the present rituals of the Order was a brilliant and highly respected leader and a master of rhetoric, there comes a time in history when changes in thinking occur in the minds of men. An outstanding example is the Holy Bible itself which has been re-worded or re-written by several scholors to convey a fuller and clearer meaning to its teachings.

While the author of this paper is not sufficiently gifted to update the wording of the Junior Past Worthy President's charge, perhaps the following may convey a basis for consideration.

"Liberty". The history of mankind is written around this word. To its sacred cause the master minds of ages have dedicated the loftiest gems of oratory and in its service, men have reached the summit of human greatness. The battlefields where vast armies fell seeking to extend some tyrant's power, may, in the fullness of time, be unmarked, unheeded and unknown; but man's love of freedom has been nurtured from time immemorial and will be unending. And, filled with the desire to live in freedom, even the humblest man will lay down his life for his country.

But the liberty of the nation is only the sum of our individual liberties and the liberty of the individual is only a bit less sacred than is the liberty of the state. It is man's right to enjoy those liberties endowed to him by his nation but it is not his right to abuse those liberties for personal and selfish fulfillment. You have no right to ask from me what you would not give to me, and I have no right to impose ideas and conditions on you, which, were I in the minority, I would not accept from you.

The courage to die in defense of one's country is no whit more praiseworthy than the courage to live worthily for one's country. And as you consecrate the fullness of the best that lies in you to our common land, give gladly, because you value your liberty, the same right to every other man to think his thoughts, to live his life, to love his country and to worship his God as you ask for yourself.

A motion was made by Brother Stokes and seconded by Dave Shay, Elmira Aerie No. 941 that the resolution be adopted as read and forwarded to the Grand Aerie Convention in Kansas City, Mo. This was approved.

#### REPORT OF THE POLICE AND FIREFIGHTERS COMMITTEE

Read by D. James Shay, Chr. Elmira Aerie No. 941

Worthy President, State Officers, Grand Aerie Representatives and My Brother Delegates:

This is a report of the Police and Fire Committee, the members are Brother Earl Willis of 2311 Maple Leaf Aerie, Toronto Canada, and Brother Frank Crowley of 941, Elmira.

This committee was first established by the State Aerie to give statewide recognition to Heroic Acts of the dedicated individuals of the Fire Service.

The responsibilities of the Committee were later extended by motion of the State Aerie to include members of the Police.

For this committee to function properly it was necessary to have input from the local aeries.

The committee set guidelines for the local aeries to follow:

- To be considered for the award the individual or individuals would have to
  perform an act which was over and above the normal service of which the individual selected performs on a routine basis. Some members, dedicated
  members of the Fire Service perform the daily chores of Fire Prevention and
  Fire Extinguishment without ever having the opportunity of performing an
  heroic act.
- After the Act was performed, the individual or individuals should remain among the living.
- 3. That documented proof be furnished to substantiate the act. The proof could be in the form of Newspaper clippings, filmed or audio portions of news programs.
- 4. The recommendations of the local aerie, with the documented proof forwarded to

- the State Secretary no later than one month prior to the Spring Officers Meeting.
- 5. Membership in The Fraternal Order of Eagles was not necessary to receive consideration of this award.
- 6. The local Aerie would make the presentation to the selected winners of the award at a function of the local Aerie.

The idea behind this award was to recognize the local hero, to give him or her statewide, national and international exposure and to provide the local aerie with an opportunity to present to the men in blue the benefits available to their families from the Eagles Memorial Fund. There are close to 800,000 firefighters and close to 75,000 police officers in New York State and Eastern Canada. I do hope that the membership committee takes note of this statistical information.

At the State Convention in 1978, I offered to come to any function that the local Aerie was having in behalf of firefighters or police at my own expense. I received one invitation and this was from President Gordon Lindow of Binghamton Aerie 2119 to attend a County Firemens Award Night in Greene, New York. I do not know whether my visit was beneficial but Brother Lindow has asked New Aeries Committee for survey information for an Aerie to be located in the Greene area.

I extend the same invitation to you my brothers, for me to attend any function in behalf of your local Police or Fire Departments at my own expense, and gas availability.

Everyone reads the newspaper, watches TV and listens to the radio. This is the source information for your selection of individuals to be considered for the Statewide Police and Fire Award. The Province of Ontario I am told is bigger than the State of Texas, extending from the eastern end of Lake Ontario to the western end of Lake Superior. The only Eagles Aeries are in the eastern portion so presentation would be difficult but if an individual was selected in the far reaches of the province, "where there is a will there is a way". I am aware that a firefighter from one of the Metropolitan Toronto Brigades had received a Provincial Citation for Bravery. I read this in the New York News and a National Magazine.

It would be possible for more than one Aerie to select the same individual to be considered for the award.

I should like to commend the selection of the two recipients of the 1978 - 1979 Eagles State Award, Captain Leidy and Firefighter Pingotti of the Middletown Fire Department. Their names were submitted by Empire Aerie 544 of Middletown, N.Y. The Aerie complied with the six (6) guidelines.

I would like to thank the members of the committee who put so much time in behalf of the activity.

I would especially like to thank my co-chairman Brother Frank Crowley who made the presentation for the Committee at the State Officers Spring Meeting.

It is the concensus of the members of the committee that his award program should continue.

#### REPORT OF THE SOCIAL SECURITY COMMITTEE

Read by Arthur Gonyea, Chr. 2486

State President, Grand Aerie Representatives, State Officers and Brother Delegates:

Social Security and Supplemental Security Income Payments will increase automatically by 9.9% beginning with the check Social Security beneficiaries will receive on July 3 and Social Security recipients on June 29th.

Social Security has a built-in cost of living increase each year. As prices increase, so do Social Security benefits. Last year (1978) the increase was 6.5%. This year, as stated above, the benefits will increase 9.5% in July, 1979. It is difficult to keep up, however, as the prices rise so fast.

Elderly people still have a difficult time making ends meet. Social Security continues to pay disability benefits to totally and permanently disabled workers and their families. This is a very important program, as benefits are paid to eligible disabled workers at any age. The main purpose is to provide income to those disabled workers and to promote their rehabilitation and return to work.

Calculation of the increase in benefits was based on the revised CPI for urban wage earners and clerical workers for the first quarter of 1979. By 1980 costs to the trust funds of the Social Security increase will be 10.2 billion. By 1980 cost to general revenues of the Social Security increase will be \$415,000,000.

Examples of monthly payments before and after the increase are at levels ranging from \$284.10 to \$312.30, which is the increase for a couple to a high of a maximum benefit for a worker retiring at age 65 in 1979 being raised from \$503.40 to \$553.30 per month.

With the ever increasing raise in our cost of living, we of your committee, are conscious of the fact that the Social Security benefits are of the utmost importance to all concerned, and we hope that there will be a solution to the many problems concerning Social Security so we will all be able to benefit by it when we reach retirement age.

WHEREAS: most of our towns, cities, counties and States are making no concerted effort to control child abuse, and

WHEREAS: the constitution of the United States grants equal protection, under its laws, to all people, regardless of race, color, creed or origin, and

 $WHEREAS: \ the \ constitution \ of the \ United \ States \ protects \ against \ all \ cruel \ and \ unusual \ punishments, \ and$ 

WHEREAS: these abused children are being denied their constitutional rights and are not capable of defending themselves, we, members of the Fraternal Order of Eagles urge congress, in session, to adopt laws as follows:

- 1 Imprisonment for all persons abusing children.
- $2\mbox{ \cdot } Imprisonment$  for all persons knowingly allowing children to be abused and not reporting the same.
  - 3 Permanent removal of abused children of parents, parent or guardians.

We wish to thank the Golden Eagle Fund Grand Aerie Committee for the \$1,000 grants received to date. To the bonified Senior Citizen Units that were the recipients have had their lives changed from boredom to one of fun and enjoyment.

The majority of our aeries and auxiliaries have put in many hours to entertain our

senior citizens and raise money for this project. To date we have received \$3450.46.

This Foundation is governed by the Government Disclosures Act and where there is no active campaign to collect funds, where the funds are not used but invested and just interest used we have to lose our tax exempt status. Because of the scope of the benefits from these funds, we need to protect them by making additional collections from both the aeries and auxiliaries. He concluded his remarks by saying "I am sure we do not want this Eagle Village and the Memorial Fund disbanded."

While awaiting the report of the Election Committee a special Order of business was called during which many topics were introduced and many of the delegates took
