1984 STATE CONVENTION

Although the majority of delegates and visitors arrived in the Convention city of Utica, N. Y., on Wednesday, June 13th, a number of "Early Birds" and a majority of the Eagle Golfers were greeted by the Utica Committee a day earlier in preparation for the golf tournament scheduled for 8:00 AM Wednesday. A "Get Acquainted" party was held in the Aerie Home Wednesday evening and the buffet room was filled to capacity.

The annual Prayer Breakfast was held in the Aerie Home on Thursday morning followed by registration of the State Aerie and State Auxiliary delegates and visitors. All State Aerie business sessions were held in the Aerie Home and the State Auxiliary business session were conducted in the Knights of Columbus gym, a short distance from the Headquarters Hotel.

A Joint Memorial Service was held in the Aerie Home Friday evening and the Joint Convention was held at the Twin Ponds Country Club Saturday evening.

OFFICIAL OPENING OF THE CONVENTION

The convention was officially called to order by State President Arthur Gonyea at 2:00 PM in the home of Utica Aerie. REPORT OF THE JUDICIARY COMMITTEE

Read by Arthur Cichon, Chr., Depew-Lancaster Aerie No. 2692

RULES OF THE CONVENTION:

Credentials for admission: Properly accredited delegates and Past Worthy Presidents along with Ten Year Secretaries shall obtain their credentials from the proper committee upon presentation of official receipts showing that they are in good standing in their aerie.

No person shall be admitted to the main floor unless he is a delegate. Past Worthy President or Ten Year Secretary. He must display his credentials and deposit the daily attendance slip with the proper aerie officer. A visiting member in good standing, not a delegate, may attend the convention sessions, in a section set aside by the committee, as a spectator only.

A delegate desiring to be heard on any subject, which is properly before the Aerie, shall rise, give the salutation sign, address the Worthy President, state his name and number of his Aerie. When recognized by the President he may proceed.

A question indefinitely postponed shall not again be considered, except by the action of two thirds of the delegates voting again to take up the matter.

Voting shall be by the voting sign of the Order, except upon Roll Call, then it shall be by aye and nay vote. Any thirty persons may demand a roll call on any question, but such demand shall be made before voting on the question.

Nominating speeches shall be limited to three minutes each and seconding speeches to two minutes each.

The election shall convene in the ante room adjoining the meeting hall on Saturday, June 16, 1984 from 8 AM to 10 AM. Only official ballots to be received. The count shall begin promptly at the close of the polls and continue to the completion thereof.

Delegates must present their credentials and ballots, depositing the latter in the ballot box. First ascertaining the number of votes indicated on the credential is identical with that indicated on the ballot and that no erasures appear thereon.

All resolutions must be reduced to writing, typewritten in triplicate if possible, and delivered to the State Secretary for distribution to the proper committees. The Committee on resolutions will, at the proper time, report all resolutions to the convention, with recommendations thereon.

Any part of the issue not covered by the rules of the convention or the rules of order shall be governed by Robert's Rules of Order Revised.

At this time it is customary to read the Order of Business for the convention, but in view of the fact there is no great change in the procedure, as regards to previous sessions and also that copies of the Order of Business have been distributed to all of the delegates, I shall dispense with the reading of the same, if there is no objection.

He also emphasized the importance of an active and successful aerie both numerically and financially and what the members can and must do to make this happen. He stressed the importance of officers doing their duties. In closing, he expressed his thanks for the hospitality that he has received in his many visits and extended his best wishes for a most successful convention.

STATE SECRETARY'S REPORT

Read by State Secretary Laverne "Shorty" Weber, Lockport Aerie No. 825.

Grand Aerie Representatives, State Officers and Brother Delegates,

Again it is a privilege and pleasure for me to give you this brief report on the programs and activities that have taken place in the New York State Jurisdiction over the past twelve months. Complete and detailed reports will be given by the State Committee Chairmen in relation to their respective projects.

In our new membership program, we added a total of 2799 new members to our rolls, exceeding last year's total by 220. This was accomplished only by the efforts expended by the membership department and the local aerie producers. Without the efforts and help from each and everyone of you, this could not have been accomplished. The charters of four aeries have been or are in the process of being revoked over the past year. They are Syracuse 053, Long Island City 1509, Montreal 2130 and North Montreal 3899. Without the institution of a new aerie, our New York State family drops to 53 units. The official figures from the Grand Secretary's Office show a total of 16,174 members on the New York State Aerie rolls. An increase of 100 over last year's report. As in the past, a number of aeries did not report until after the survey and were not counted.

Although we are told that inflation has been curbed, the high cost of supplies, food, travel and lodging continues to haunt all of us. We are proud, however, that none of our programs and services have been curtailed. This was due in part because so many of our State and Local leaders gave so generously of their time and efforts without any remuneration whatsoever. Our balance as of May 31st is \$5,989.40 of which \$1,973.50 is earmarked for the State Arthritis Fund leaving us a working balance of \$4,016.90. The State Secretary's financial report is on the secretary's desk, available for inspection, and will be included in the proceedings of this convention.

A nice delegation from the New York State family traveled to Nashville to take part in the business sessions of the Grand Aerie Convention and in their spare time enjoyed the hospitality of the host city. The New York State Hospitality room was superb in every way and the New York Marchers won third place in the parade. Carol Shay was re-elected Grand Madam Trustee and yours truly, "Shorty" Weber, was re-elected Grand Trustee. The appointment of Brother Robert Woodruff as Eastern Regional President put the icing on the cake.

The Fall and Spring State Officers' Conferences, held in Glens Falls and Binghamton, were well-attended and must be classed as successful and productive business and social Eagle events. You could almost say they have become a mini convention. Highlights included the selection of Rochester Aerie to host the 1985 State Aerie and State Auxiliary Convention and Binghamton as the site for the 1984 Mr. and Mrs. State Bowling Tournament. Past State President "Bob" Woodruff was appointed to serve as State Membership Director for 1984-85 and Rotterdam Aerie was chosen to host the Fall State Officer's Conference in September.

All local aeries and auxiliaries continue to donate generously to our humanitarian funds and it is because of this generosity that a number of grants have been presented to deserving institutions from the Cancer, Jimmy, Golden Eagle and Heart Funds. Two seven thousand dollar (\$7,000.00) grants were presented, from the State Arthritis Fund, by Rochester and Tonawandas Aeries. Grand Aerie Representatives, State Officers and Brother Delegates:

As you know, the cost of the postage Stamp is going up in September. There is not much we can do about this. However, we can do something in the future.

Senator Alfonse D'Amato, who is a member of the Senate Appropriations Committee, and his colleagues have kept the cost from going even higher with the continuation of Resolution H.J. Res 413 now P.L. 98-151. A letter explaining this in more detail has been sent to all aerie secretaries. If each Aerie would have a few members send a postcard to Senator D'Amato in support of continuing Resolution P.L. 98-151, it could help in keeping any future costs down.

Now we get to Assemblywoman Lipschutz. She is proposing an amendment to Section Nine of Article One of the Constitution relative to authorizing slot machines. This resolution would amend the constitution to permit slot machines in certain areas of the state after local approval. The state would in turn receive revenue in the form of a tax on the machines. A state-wide proposition on the amendment would be submitted to the voters if this resolution is passed by two separately elected legislatures in 1984 and 1985.

I believe that if this amendment is passed, we will have a foot in the door to legalizing Games of Change. Maybe in time slot machines.

A more detailed report on this bill will be mailed to all Aerie secretaries in the near future. Once again I ask for your help by sending a letter or postcard to Assemblywoman Lipschutz.

Brother Delegates:

Not being able to overcome the slow start we encountered at the beginning of the year was one of the big factors in not reaching the 3000 new member goal that State President Art and I set last June when we started. But, I will take the 2799 new members we got along the way and I know Brother Art is pleased as well. We know it was all of you that made this possible. All you Eagles who went out and signed up a new member for the New York State Aerie. From the entire New York State Membership Department, we thank you for the 110 percent effort given.

The Early Bird Campaign, during June, July and August put 440 new members on the rolls. The State Secretary's Campaign was held during the month of September and 222 more new members were added. Lockport Aerie No. 825 captured the most new member plaque and the percentage gain plaque went to Elmont Aerie No. 3128. The November Hunters Campaign, one of our bigger campaigns so far, brought in another 273 new members. Rochester Aerie No. 52 took the Hunter's Trophy by reporting the most new members and

Ossining Aerie No. 1545 took the Membership Percent Gain Trophy. The Football Campaign during October, November and December gave us a total of 704 new members. Ossining Aerie No. 1545 captured the 'HARRY WOODRUFF' Traveling Award for the best percentage gain for the three month period. As we moved into 1984 and the State President's Campaign in January, we chalked up a big 278 to our growing membership total. Watertown Aerie No. 782 took home the State President's Trophy and also the State Membership Trophy for reporting the most new members and the best percentage gain. A disappointing February and Police and Firemen Campaign only gave us 166 new members to add to our rolls. Special plaques were presented to the Aerie in each zone reporting the greatest percentage gain. Batavia No. 2348, Cortland No. 2191, Glens Falls No. 2486 and Ossining No. 1545. No new members were reported in Zone 5 during February. The Under 35 Campaign in March brought in a great big 388. Watertown took home the plaque for reporting the most new members and the percentage gain plaque went to Fort Erie No. 3155. The Old Timers Campaign during April added another 345, a few less than the Under 35'ers. Ossining Aerie No. 1545 again a winner and taking the traveling "AL LANE CUP" with a whopping 50 percentage gain. REPORT OF THE SOCIAL SECURITY COMMITTEE

Read by Gordon Brenenstuhl, Chr., Hoosick Falls Aerie No. 2467

Brother Officers and Delegates:

Social Security is one of the first things that a person thinks of when they approach retirement age. They know that they can receive a check when they retire, but that's about all they are sure of.

Correct information about Social Security may change as time passes. Before anyone acts upon retirement they should contact a Social Security Office to get up-to-date information. Often this is put off too long and there is a delay in checks or insurance coverage. This can be avoided by contacting your Social Security Office by phone or in person. The people are there to help you.

Before you can get retirement checks you must have credit for work covered by Social Security. The exact amount of credits depends on your age.

You are the only person that can decide the time you retire. There will be many things involved in your decision. A company pension, your health, your financial situation or your ability to keep working will influence your decision. Another factor is a three percent increase for each year that you work past 65.

Even if you don't retire, its important to contact your Social Security Office two or three months before you or your spouse reach age 65 to arrange for your Medicare health insurance protection to start at 65. If you wait until you reach 65 or later you will loose one or more months of Medicare insurance protection. This is important because many health insurance plans adjust their coverage when a person reaches 65. By all means get in touch with the agent where you pay health insurance and discuss your needs in relation to Medicare protection

Benefit payments will vary. Once you are on the Social Security Rolls, your checks will automatically increase to keep pace with the cost of living. If you continue to work, you can earn up to \$6,900.00 and still receive all benefits due you.

Beginning in 1984, up to half of your Social Security benefits could be taxed if your adjusted gross income is more than \$25,000 for a single person or \$32,000.00 for a married couple.

If you are planning on retiring soon, please contact your Social Security Office about six months ahead of your retirement date. Make sure you take your birth certificate, your W-2 forms for the past two years and your marriage license if your spouse is eligible for benefits.

This report is submitted with the hope that any information it contains will be of help to anyone that is considering retirement.
