1987 STATE CONVENTION

The eighty-first State Convention held in the City of Watertown got off to a great start with the Annual Bill Carrick Golf Tournament being held on Wednesday. They teed off at the Willowbrook Gold Course with a little rain to help them along. After the match, they all returned to the Aerie home for prizes and libation. A great time was had by all.

In the evening, a get-together was held at the Aerie home with a lot of delegates greeting each other and much conversation as a lot had not seen each other in a year. Registration went very well and the accommodations were very good.

On Thursday morning, a prayer breakfast was held at the Aerie home at 8:00 A.M. and was well attended. Father Walter Giles of Trinity Church and Monsignore McCarthy of Holy Family Church were the fraternal speakers. Monsignore McCarthy certainly stole the show.

All business sessions of the Aerie were held in the Aerie home. The Ladies Auxiliary met at the State Office Building.

The Joint Memorial Service was held at the State Office Building on Friday night. A larger attendance was on hand and a very solemn ceremony was presented. The convention banquet was held at the Northside League and was a very successful event. Many dignitaries were on hand and the meal was just great.

OFFICIAL OPENING OF THE CONVENTION

The convention was officially called to order by Watertown Aerie President Gary LaRose at 1:00 P.M., Thursday, June 18, 1987, in the home of the Watertown Aerie. The Colors were presented by the "Thunderbirds", the Watertown Jr. Eagles, and Past State President Donald Rettinger of Toronto, Canada led the delegation present in the singing of the National Anthems of the United States and Canada. Father Walter Giles provided the invocation. Watertown Aerie President Gary LaRose and Auxiliary President Margaret Brady welcomed everyone to Watertown and to the Convention, and offered warm wishes for a wonderful and safe convention. Alfred Gianfagne, M.D., a Watertown Pediatrician, welcomed everyone and then discussed the Tompson Park Playground for handicapped children. He advised everyone that \$50,000 was raised by projects held at the Eagles Club and that this playground would not have been possible without all the hard work and dedication of members of the Eagles. He congratulated everyone and gave heartfelt thanks for getting this project off the ground. T. Urling Walker, Mayor of Watertown, Michael Hennigan, Chief of Police, and Charles Bolio from the Town of Watertown Fire Department all extended welcomes to the City, and extended sincere compliments on the dedication, companionship and enthusiasm they have seen among members of the Eagles. Grand Worthy Vice-President Laverne "Shorty" Weber, Kenneth Amsbaugh, Past Grand Worthy President, and Eastern Regional President Wayne Monroe all offered greetings for an enjoyable and safe Convention. Katherine Gonzagowski, Grand Madam Trustee, extended a cheerful welcome to all, as did Joan Farrell, Auxiliary State President. State President Al Hubbard welcomed everyone on behalf of New York State and thanked his wife for being so patient during the year. Father Giles offered Benediction which brought the official opening ceremony to a close, after which a short recess was called prior to the first business session.

REPORT OF THE JUDICIARY COMMITTEE

Read by Laverne "Shorty" Weber, Lockport Aerie 825

RULES OF THE CONVENTION:

Credentials for admission: Properly accredited delegates and Past Worthy Presidents, along with Ten Year Secretaries, shall obtain their credentials from the proper committee upon presentation of official receipts showing that they are in good standing in the Aerie.

No person shall be admitted to the main floor unless he is a delegate, Past Worthy President, or Ten Year Secretary. He must display his credentials and deposit the daily attendance slip with the proper Aerie officer. A visiting member in good standing, not a delegate, may attend the convention sessions, in a section set aside by the committee, as a spectator only.

A delegate desiring to be heard on any subject, which is properly before the Aerie, shall rise, give the salutation sign, address the Worthy President, state his name and number of his Aerie. When recognized by the President, he may proceed.

A question indefinitely postponed shall not again be considered, except by the action of two-thirds of the delegates voting again to take up the matter.

Voting shall be by the voting sign of the Order, except upon Roll Call, then it shall be aye or nay vote. Any thirty persons may demand a roll call on any question, but such demand shall be made before voting on the question.

Nominating speeches shall be limited to three minutes each and seconding speeches to two minutes each.

The election shall convene in the Aerie Home where the Credentials Committee is meeting on Saturday, June 20, 1987, from 8 A.M. to 10 A.M. Only official ballots to be received. The count shall begin promptly at the close of the polls and continue to the completion thereof.

Delegates must present their credentials and ballots depositing the latter in the ballot box, first ascertaining the number of votes indicated on the credential is identical with that indicated on the ballot and that no erasures appear thereon.

Any part of the issue not covered by the rules of the convention or the rules of order shall be governed by Robert's Rules of Order Revised.

At this time, it is customary to read the Order of Business for the convention, but in view of the fact there is no great change in the procedure as regards to previous sessions and also that copies of the Order of Business have been distributed to all of the delegates, I shall dispense with the reading of the same, if there is no objections. However, they will be included in the convention proceedings.

FIRST REPORT OF THE BY-LAWS COMMITTEE

The By-Laws Committee proposes the following changes to Sections 5-7, 4-1, and 3-3:

Section 5-7: The State Aerie Representative to the Grand Aerie Convention shall be the Jr. Past State President at the time of the Grand Aerie Session, or his duly elected alternate and the serving State Membership Director. If the State Secretary does not receive a major Grand Aerie assignment, he will be allowed the same compensation as the Jr. Past State President or alternate. The compensation for each shall not exceed \$25.00 per diem plus the approved registration fee and actual Pullman fare or airline fare, or if traveling by automobile, not in excess of fifteen cents per mile while going to or returning from and while in actual attendance at the Grand Aerie Session. In no event shall the expenses exceed \$350.00.

Section 4-1: The State Aerie shall fix the amount of the per capita tax in Annual Convention for the coming year, following the recommendations of the Budget and Finance Committee, for each member whose name appears on the membership roll of the local Aerie on the date upon which the per capita tax, the same to be paid semi-annually on or before January 1st and on or before July 1st of each year, not in excess of \$1.00 per annum. Any contemplated increase in the State per capita tax by the State By-Laws Committee must be made a matter of public record to every local Aerie in the State jurisdiction at least 30 days before the Annual Convention.

Section 3-3: The term of all State Officers of the State Aerie shall be for a period of one year except for the offices of the State Secretary and the State Treasurer, which shall be for a period of three years.

The second and final reading of the above proposed changes will be given at the next two sessions.

REPORT OF THE STATE LEGISLATIVE COMMITTEE

Read by Robert Yager, Chr., Canajoharie Aerie 3846
Brother Delegates:

The Fraternal Order of Eagles, some seven years ago, started the Conference of Private Organizations in New York State. The Committee, at that time from the Eagles, consisted of one person from each Zone. We have since dropped our name from the CONPOR roles.

The current legislation in the State that would affect us is as follows:

1. In Buffalo, we have a problem that could spread to other parts of the State. The Buffalo City Council Committee held a hearing on a proposed law intended to "end discrimination in all male clubs." The way the proposed law is written, it would affect our organization. The law is similar to New York City's Local Law #63 (NYCLL #63). This legislation was proposed by Buffalo City Councilman James W. Pitts (Resolution #245). IMPORTANT NOTE: The proposed law is aimed at the Buffalo Club, BUT does not contain the exclusion of clubs that are incorporated or described in the Benevolent Orders Law of New York State as do NYCLL #63 and the State Legislation. We need to add an exclusion clause for organizations listed under New York State's Benevolent Orders Law. Councilman Pitts hopes to pass this into law in July. Anyone who can assist us in this matter is asked to contact the Chairman.

2. The Bell Jar (lucky sevens) Bill has passed the Assembly and is expected to pass the Senate. We don't expect the Governor will sign this Bill into law this year. We are getting very close to seeing the day when lucky seven tickets will be legalized.

3. Raffles are also very close to becoming legalized. The New York State Fireman's Association have been working very hard to get this passed in New York.

4. State Secretary Wayne Monroe attended a PANCO Meeting in Pennsylvania. PANCO is the sister organization of New York State's CONPOR. PANCO is not only getting involved with proposed legislation, but they are getting involved in many areas of club operation. Wayne gave a positive report of the PANCO Meeting.

REPORT OF THE SOCIAL SECURITY COMMITTEE

Read by Salvatore Ventura, Depew Aerie 2692

State President, Grand Aerie Representatives, State Officers and Brother Delegates. Social Security is a benefit that a lot of us will be looking into a short time down the road, as have over 37 million other Americans at the present time.

There have been a great number of changes in Social Security in the past several years. Medicare Part B has increased the monthly premium in the year 1987. You can receive all payments due you if your earnings do not exceed the annual exempt amount. This limit in 1987 is \$8,160.00 for people 65-70 and \$6,000.00 for people under 65.

Starting in 1990 and the year 2000, there are more benefit changes coming that will affect many of us. This Committee suggests that you keep in close contact with your Social Security Office at all times so that you understand all these benefit changes that are and will be forthcoming. One important item we would like to mention is in the year 1987, all dependents over the age of 5 must have a Social Security number or face a \$5.00 penalty fee.

The Social Security Administration and financial institutions are more and more recommending that you have your Social Security check direct deposited to your savings or checking account. This alone saves the Administration millions of dollars every year, and also eliminates you from standing in line to cash your check, worrying about losing or having your check taken.

If you wish to arrange for direct deposit, contact your local bank and ask for Form SF-1199. In most cases, they will help you fill it out correctly. It is also very important to report any change of address to your Social Security Office.

The Social Security Administration also recommends that you call your local office before you visit. Most matters can be handled by phone in the convenience of your home. They also note that the phones are busiest the first part of the month. So, unless you have an emergency, call after the middle of the month. They also recommend that anyone planning to retire should apply for benefits at least 3 months in advance, so when they retire, payments will start promptly.

Your Social Security Committee recommends that every Aerie contact the local Social Security office and make arrangements with them to have their field representative come to the Aerie home to discuss the benefits and changes that are forthcoming. Make sure that it is far enough ahead so that you can notify your Aerie and Auxiliary members of the date and time. This could prove very helpful and beneficial to a lot of our Brothers and Sisters.

Section 5-7: The State Aerie Representative to the Grand Aerie Convention shall be the Jr. Past State President at the time of the Grand Aerie Session, or his duly elected alternate and the serving State Membership Director. If the State Secretary does not receive a major Grand Aerie assignment, he will be allowed the same compensation as the Jr. Past State President or alternate. The compensation for each shall not exceed \$25.00 per diem plus the approved registration fee and actual Pullman fare or airline fare, or if traveling by automobile, not in excess of fifteen cents per mile while going to or returning from and while in actual attendance at the Grand Aerie Session. In no event shall the expenses exceed \$350.00.

Section 4-1: The State Aerie shall fix the amount of the per capita tax in Annual Convention for the coming year, following the recommendations of the Budget and Finance Committee, for each member whose name appears on the membership roll of the local Aerie on the date upon which the per capita tax, the same to be paid semi-annually on or before January 1st and on or before July 1st of each year, not in excess of \$1.00 per annum. Any contemplated increase in the State per capita tax by the State By-Laws Committee must be made a matter of public record to every local Aerie in the State jurisdiction at least 30 days before the Annual Convention.

Section 3-3: The term of all State Officers of the State Aerie shall be for a period of one year except for the offices of the State Secretary and the State Treasurer, which shall be for a period of three years.

The final reading of the above proposed changes will be given at the last session.
