1978 STATE CONVENTION

With the arrival of the majority of the delegates and visitors on Wednesday, June 21, 1978, we again ran into the same problem that has been plaguing convention committees for years and years -- Housing Reservations. Fortunately, a major portion of the problems were solved quickly and plans for the evening's activities went along without any interruption. A class initiation was held in the aerie home at 8 o'clock at which 16 candidates were inducted into the Order by the State Officers Degree Team. On the entertainment side the Annual Get Acquainted Party immediately followed the initiation. The dancing and entertainment were enjoyed by a capacity crowd.

All State Aerie business sessions were held in the home of Schenectady Aerie. The State Auxiliary sessions were held in the Ramada Inn. Registration of delegates opened at 10 A.M. on Thursday June 22nd on the first floor of the aerie home.

The State Convention Banquet was held on Saturday evening June 24, 1978 in the Hall of Fame Ballroom in the Ramada Inn.

OFFICIAL OPENING OF THE CONVENTION

The Convention was opened at 2:15 P.M. on Thursday June 22nd by David Waldron, Past President of Schenectady Aerie and General Chairman of the 1978 New York State Convention. James Burger, Commanding Officer of the United States Naval Reserve Security Group, led all present in the pledge of allegiance and the singing of both the United States and Canadian National Anthems. Reverend Bernard Gustas, Pastor of St. Joseph's Catholic Church gave the invocation. Speakers included James Tedisco, who represented Mayor Frank Duci, and read a proclamation establishing June 19th to the 25th as "Fraternal Order of Eagles Week". A number of city officials which included Wayne V. Chapman, City Manager; Sergeant Wemble, who represented the Chief of Police; Mrs. Karen Johnson, City Council Member; Dominic Gallo, City Council Member was unable to attend and he was replaced by Majority Leader David Roberts. Bernard Waldron, Sheriff of Schenectady County, brother of the Convention Chairman and Brother Eagle also extended a warm welcome. State President Donald Gregory, Madam State President Carmelita Pauly, Schenectady President Herbert Farrell and Madam President of the Auxiliary Gladys Barner were introduced and spoke briefly welcoming all delegates and visitors to Schenectady. Past Grand Worthy President Lewis Reed and Past Grand Madam President Adaline Navarra, along with Eastern Regional President Owen McNally all representatives of the Grand Aerie spoke extending their best wishes for a successful convention. Past Grand Madam President Mary Dunn was also introduced. Special thanks was given to State Secretary Lane for his expert guidance all along the way. M. Daniel Splain, Assistant International Director of Membership and Secretary of the Grand Tribunal was the keynote speaker and gave an eloquent address elaborating on the part fraternal organizations played in the governmental system of our country. This brought to a close the official opening ceremony. A recess was called at 3 P.M. to make the necessary arrangements for the first business session.

RULES OF THE CONVENTION

Credentials for Admission: Properly accredited delegates and Past Worthy Presidents along with Ten Year Secretaries shall obtain their credentials from the proper committee upon presentation of official receipts showing that they are in good standing in their aerie.

No person shall be admitted to the main floor unless he is a delegate, Past Worthy President or Ten Year Secretary. He must display his credentials and deposit the daily attendance slip with the proper aerie officer. A visiting member in good standing, not a delegate, may attend the convention sessions, in a section set aside by the Committee, as a spectator only.

A delegate desiring to be heard on any subject, which is properly before the aerie, shall rise, give the salutation sign, address the Worthy President, state his name and number of his aerie. When recognized by the president he may proceed.

A question indefinitely postponed shall not again be considered, except by action of two thirds of the delegates voting again to take up the matter.

Voting shall be by the voting sign of the Order, except upon roll call, then it shall be aye and nay vote. Any thirty persons may demand a roll call on any question, but such demand shall be made before voting on the question.

Nominating speeches shall be limited to three minutes each and seconding speeches to two minutes each.

The election shall convene in the ante room where the Credential Committee is meeting on Saturday June 24, 1978 from 9 A.M. until 11 A.M. Only official ballots to be received. The count shall begin promptly at the close of the polls and continue to the completion thereof.

Delegates must present their credentials and ballots, depositing the latter in the ballot box. First ascertaining the number of votes indicated on the credential is identical with that indicated on the ballot and that no erasures appear thereon.

All resolutions must be reduced in writing, typewritten in triplicate, if possible, and delivered to the State Secretary for distribution to the proper committees. The committee of resolutions will, at the proper time, report all resolutions to the convention, with recommendations thereon.

Any part of the issue not covered by the rules of the convention or the rules of order shall be governed by Robert's Rules of Order Revised.

At this time it is customary to read the Order of Business for the Convention, but in view of the fact there is no great change in the procedure as regards to previous sessions and copies of the Order of Business have been distributed to all of the delegates I shall dispense with the reading of the same if there is no objection. However they will be included in the Convention proceedings.

From St. Jerome Aerie No. 3176 an itemized report of the donations made by the aerie and auxiliary to local charities which amounted to \$14,141.06. Filed.

The co-operation that was given to all the chairmen of the various Grand Aerie Humanitarian Funds will once again put us up with the National leaders in monies donated.

All of my visits to the various aeries whether for business, social occasions, anniversaries or just to say hello were all happy events because of the manner in which my wife Ronnie and I were received and the splendid hospitality that was shown at all times.

It would be most difficult to thank personally, all who were responsible for this outstanding year, but I would like to express my sincere appreciation for the excellent co-operation and support I got from all of the State Officers, in particular State Secretary Lane, the Zone and District leaders and most of all the local aerie leaders and members who made all of these wonderful things happen.

In closing I want to extend my congratulations to my successor Brother Cichon, along with my pledge to assist him in every way to duplicate or perhaps better the year just passed.

STATE SECRETARY'S REPORT

Read by State Secretary Alfred W. Lane, Tarrytown Aerie No. 1042.

Brother Delegates:

This is the 23rd time that I have had the privilege and the pleasure of presenting the Secretary's Report. Again, as in the past you will find that this is a synopsis of what has transpired during the past 12 months and a preface of the reports that will be elaborated on as the convention progresses.

To me our greatest accomplishment was in the New Membership field. We gained Nationwide attention by instituting 5 new aeries into the New York State Eagle Family during the past year an our overall total of 2728 new members belies the statement that interest in fraternal organizations is growing weaker year by year. Although we do have a few weak units, no charters were revoked or surrendered during 1977 - 1978 leaving us with a total of 53 local aeries in the State jurisdiction.

Official per capita tax figures received from the Grand Aerie, as of December 1977 is 14,848. The official figure last year was 15,701 which would indicate a net gain loss. Again, I must point out that the figures of the aeries reporting after the survey was taken were not counted.

One of the chief topics in our world today is the high cost of living and the ballooning inflation. Our balance as of May 31, 1978 is \$5,471.25. The State Secretary's Financial Report is on the Secretary's desk for inspection and will be included in the Convention proceedings. During the past few years we did manage to continue all of our services within our financial boundaries only because so many of our State and local leaders gave their support to so many of our programs and campaigns, in the majority of cases, without any remuneration whatsoever. After many discussions it was agreed almost wholeheartedly by all concerned, that a raise in the present State Per Capita Tax is a must in order to continue as one of the better State Aeries in the jurisdiction.

A large number of the Local aeries and auxiliaries were represented at the Grand Aerie Convention in Minneapolis and took an important part not only in the business sessions but also in the Convention Parade and the fun sessions as well. A number of our brothers and sisters were appointed as Eastern Regional representatives but the highlight was when Owen (Big Daddy) McNally was selected as Eastern Regional President.

Our Fall and Spring Conferences held in Utica and Tonawanda respectively were business and social successes again. Each year the attendance at these important gatherings is gaining in numerical strength making them top attractions on our annual program sheet. Highlights included selecting Binghamton as the site of the 1979 State Convention, selecting Captain Frank Banks of the Elmira Fire Dept. as Fireman of the Year and Patrolman Perry Specchio, of the Watkins Glen Police Dept. as Policeman of the Year. Past State President Laverne "Shorty" Weber was picked to lead the State Membership Department for 1978-1979. The 1978 State Mr. and Mrs. Bowling Tournament went to Hornell Aerie and Depew-Lancaster was selected as the site for the State Fall Conference in September.

FIRST REPORT OF THE RESOLUTIONS COMMITTEE

RESOLUTION NO. 1

Read by William Carrick, Chr. Empire Aerie No. 544

WHEREAS: In the past, the meeting dates of the Annual State Convention were scheduled for the fourth weekend during the month of June, and

WHEREAS: A number of schools hold their graduation exercises during that same period at which a great number of Eagle members will attend, forcing them to miss the convention that year.

THEREFORE LET IT BE RESOLVED: The meeting dates of the Annual New York State Convention F.O.E. be changed from the 4th weekend in June to the third weekend in June.

This resolution was presented by Elmira Aerie No. 941. It was approved by the local aerie at its regular meeting on June 15, 1978 and signed by Aerie Secretary James Laskaris.

Brother Carrick stated the committee favored this move and that the resolution be turned over to the By-Law Committee. He moved such action be taken. This was seconded by Wayne Monroe, Elmira Aerie No. 941 and carried.

FIRST REPORT OF THE BY-LAW COMMITTEE

Read by William Carrick, Chr. Empire Aerie No. 544.

Brother Delegates:

After careful consideration your By-Law Committee presents the following changes to our present By-Laws:

Section 1:1 Change from -- The State Aerie shall meet annually in the month of June, starting on the Thursday of the last week, where there are at least two remaining days in June -- to read -- The State Aerie shall meet annually in the month of June starting on the Thursday which includes the third Saturday of the month.

Section 4:1 Change from -- Per Capita tax to be paid semi-annually on or before January 1st and on and before July 1st of each year, not in excess of 50 cents per annum. -- to read -- Per Capita Tax to be paid semi-annually on or before January 1st and on and before July 1st of each year, not in excess of 70 cents per annum. The same to be paid in United States currency.

Section 5:1 Change from -- Or eight cents per mile if traveling by automobile -- to read -- or 12 cents per mile if traveling by automobile.

Section 5:6 Change from -- Or eight cents per mile if traveling by car for the distance to and from destination -- to read -- Or 12 cents per mile if traveling by car for the distance to and from destination.

Section 5:7 Change from -- Or if traveling by automobile, not in excess of eight cents per mile while going to or returning from, and while in actual attendance at the Grand Aerie Session. In no event shall the expense of each exceed \$250.00 -- to read -- or if traveling by automobile, not in excess of 12 cents per mile while going to or returning from, and while in actual attendance at the Grand Aerie Session. In no event shall the expense of each exceed \$350.00.

Section 8:9 Change from -- Such rules by its adopted, subject to the approval of the State Trustees -- to read -- Such rules may be by its adoption, subject to the approval of the State Executive Committee.

As this was the first reading no action was taken.

FINAL REPORT OF THE BY-LAW COMMITTEE

Read by William Carrick, Chr. Empire Aerie No. 544.

A complete reading of the proposed By-Law changes, which were introduced at the Thursday session, was again given in its entirety. Official action was taken on each section separately:

Section 1:1 Which was in reference to changing the Annual Convention dates from the fourth weekend in June to the Thursday of the last week which includes the third Saturday of the month. A motion to adopt was made by Brother Carrick and seconded by Wayne Monroe, Elmira Aerie No. 941. This was approved. It was explained at this time that the convention scheduled for 1979 might have to be exempt from this ruling because of previous commitments.

Section 4:1 Which was in reference to raising the State Per Capita from 50 cents per annum to 70 cents per annum based on United States currency. A motion was made by Brother Carrick that this section be adopted. This was seconded by Arthur Cichon, Depew Aerie No. 2692. On the question State Secretary Lane spoke at length with relation to the payment in United States currency. He stated he had several meetings with the Canadian delegates and they objected to payment based on United States currency claiming their per capita tax was being raised and they were further being penalized because of the fiscal rate exchange that they had no control over. It was suggested that the New York State Aerie open a checking account in one of the Canadian banks. Brother Lane further stated that he agreed wholeheartedly with their objections and moved that the motion be amended so that the wording "Based on United States currency" be deleted. This was seconded by Charles Straub, Hoosick Falls Aerie No. 2467 and carried. The main motion was then voted upon and unanimously approved.

Section 5:1 Which was in reference to changing the mileage expense from 8 cents per mile, while traveling by automobile to 12 cents. A motion was made by Brother Carrick and seconded by Ralph Pauly, Olean Aerie No. 616 that this be adopted as read. Carried.

Section 5:6 Which was in reference to changing the mileage expense from 8 cents while traveling by automobile to 12 cents. It was moved by Brother Carrick that this be adopted as read. This was seconded by Richard Updike, Elmira Aerie No. 941 and carried.

Section 5:7 Which was in reference to changing the mileage expense from 8 cents while traveling by automobile to 12 cents. Also changing the maximum amount of expense for each from \$250.00 to \$350.00. A motion was made by Brother Carrick and seconded by Albert Thurber, Lansingburgh Aerie No. 3773 that this section be adopted as read. This was approved.

Section 8:9 Which is in reference to changing the wording State Trustees to State Executive Board. It was moved by Brother Carrick, that this section be adopted as read. This was seconded by Gordon Lindow, of Binghamton Aerie No. 2119 and carried.

Brother Carrick proposed that all action taken with reference to the new amendments of the New York State Aerie by-laws be adopted and a complete copy of the same be sent to the Grand Secretary for his approval. Alfred Lane, Tarrytown Aerie No. 1042, seconded the motion. This was approved by the delegates.

REPORT OF THE STATE MEMBERSHIP DIRECTOR

Read by State Membership Chr. Alfred Lane, Tarrytown Aerie No. 1042.

Brother Delegates:

We have much to cheer about this particular year adding five new aeries to our State Family -- a feat most of us consider a modern miracle. Once again we did not reach the 3,000 new member mark, a perpetual quota we always set for ourselves, but we did secure an overall total of 2,728 new members, 557 more than the 1976-1977 figure.

Our State-wide Campaigns started off slowly but were really traveling full speed ahead at the close of the fiscal year. The institution of Lansingburgh Aerie early in June gave us a nice start for the Summer Campaign. The Kick-off Campaign in September produced 203 new members. The Hunter's Campaign in November was a big disappointment to all with only 145 new members being reported. Depew and Elmira tied for top honors and each received a Hunter's Trophy. Granville with a percentage gain of 13% was awarded the Percentage Gain Trophy. The State President's Trophy was won by Rochester and the State Membership Trophy for the best percentage gain was won by Endicott with a gain of 6.5%. The Under 35 Membership Campaign Plaque for the most members reported in March was won by Elmira with a total of 30 new members. Syracuse was the winner of the best percentage plaque with a gain of 16%. April, our annual Old Timers Campaign month became the most productive month in our fiscal year with 470 new members added to the roll. This was made possible with the institution of 2 new aeries -- namely Metro Aerie, in Colonie, N.Y. and Mississauga Aerie in Ontario Canada. The first winner of the Al Lane traveling Trophy presented for the best percentage gain during the Old Timers Campaign was Endicott Aerie with a gain of 19.8%. May was another banner month with an additional 440 new members reported. Two more new aeries joined the State Eagle Family group. One in Horseheads, N.Y. and the other in Shawinigan Falls, Quebec, Canada, bringing to a very happy and successful conclusion a most progressive new membership year.

For the third consecutive year a concerted effort was made to have all the local aeries report at least one new member each month. Our average was about 50% most months. However, 37 out of 50 aeries joined the Quota Aerie Group. A number of them going over the assigned quota many times. Following is a list of this year's Quota Aeries:

Again this year we set up a little award program -- not as a reward but as a token of our appreciation for the efforts expended. The Membership Chairman of each Quota Aerie received a handsome wallet -- 37 wallets were distributed. An Eagle Drinking Cup went to all producers securing three new members in any given month. They also received an additional cup for each additional three as well. 128 cups were awarded. Each member securing 10 new members during the fiscal year was presented with a traveling alarm clock. 26 were presented. Becoming a member of the Exclusive 25 Club entitles you to a \$25.00 cash award. This year we had five. Romeo Bertrand, of Montreal; Mason Brunskill, of Hornell; Edward Barrett, of Elmira; Richard Magill, of Rochester; and Virgil Stimpson, of Oneonta. The top Producer Award of \$50.00 goes to Romeo Bertrand, the leading producer for the past two years, from Montreal Aerie who secured 42 new members. The \$25.00 award for the runner-up position goes to Mason Brunskill, of Hornell, who reported 33 new members.

Each month a small plaque was presented to the aerie with the greatest number of new members reported. The New York State Membership Trophy for 1977-1978, which is presented to the aerie with the highest total of new members reported during the year goes to Elmira Aerie with a total of 208. Following are the aeries that completed the Big Five in the State Membership Derby: 1. Elmira 941 - 208; 2. Rochester 52 - 178; 3. Montreal 2130 - 162; 4. Rotterdam 3610 - 122; 5. Depew-Lancaster 2692 - 112.

Our Zone and District setup along with your help worked wonders again this year. Gordon Brenenstuhl had the honor of being top Zone Director. His total of 1,135 for the year was one of the highest recorded in quite a long period of time. Frank Crowley was top District Director with 448. A special tap on the back must go to District Directors Stuart Gardner, Arthur Gonyea, Rene Lessard, Calvin Morton, Frank Crowley and Maurice Helmer who had all Quota Aerie in their particular Districts.

When it is all said and done you know and I know that it is the individual producer that contacts the potential member and makes him part of our great fraternity. To you brothers along with our State and local leaders my sincere thanks for your wonderful co-operation. An extra special thank you to Charles Straub, Dave Shay, Don Rettinger, Louie Dion, Andre Caron, Al Thurber and all their energetic helpers who made five new aeries in one year possible.

At the Spring Conference in Tonawanda I asked that I be relieved of the duties in connection with the State Membership Director's Office. They granted my request and in my place they appointed Past State President Laverne (Shorty) Weber of Lockport Aerie. Brother Weber has years of experience in the Membership Field and in my humble opinion will do wonders towards keeping our State Eagle Family membership strong and right up there with the National leaders.

In closing I want to say thank you again for the wonderful support I received as Membership Director throughout the years and present the brother who is going to take you to greater heights, your new State Membership Director "Shorty" Weber.

At the last State Convention under a motion of a delegate from Jamestown Aerie an award for the Fireman of the Year would be recognized by a vote of the State Aerie. This idea was affirmed.

As chairman of this committee I indicated that I was willing to work with any aerie in recognition of the firefighter and his dedication to the needs of the community, citizens, neighbors, friends and relatives.

I also indicated that I was willing to travel to any aerie in the State to assist physically in whatever manner I could to assist their program. These trips, depending on my work schedule, would be made at my expense. I received invitations from Binghamton and Hoosick Falls.

In Binghamton they presented an award to the family of a firefighter who lost his life in the performance of his duty in December 1977.

In Hoosick Falls they honored, along with members of their Fire Dept., Past Worthy President Henry Lemon, who at all times assisted the Fire Companies and was instrumental in having a Firemens' Dinner to honor all the firemen of the community.

Lockport Aerie has committed themselves to underwrite the purchase of a fully equipped Emergency Resue Van for the local Fire Department. Ten thousand dollars has been donated to the city as a partial payment.

A communication was sent to all aeries by the State Secretary requesting submission of names to be considered for recognition as the State Fire Fighter of the year. Only one communication was received. Fire Fighters from your area that were deserving of recognition were not given the opportunity to be considered for the award.

Even with the poor participation, on the part of the local aeries, we believe that this program should be continued.

Just a few words to our Membership Chairmen: In the State of New York there are at this date 126,000 firemen, at all levels. One of the best selling points to this particular group is the increased benefits provided to their families, in case of death, in the line of duty, from the Memorial Foundation Fund.

The Fireman of the Year Award was presented to Captain Frank Banks, a member of the Elmira Fire Department for bravery well beyond the call of duty when he removed three persons from a burning building at 1020 Lake Avenue on November 19, 1977.
