## 1982 STATE CONVENTION

As early as Tuesday June 15, 1982, a number of the "Early Bird" delegates and visitors started to arrive in the convention city of Elmira. Early Wednesday morning all the golfers headed for the Mark Twain Golf Course for the annual tournament held before the official opening of the convention. The majority of delegates started arriving later Wednesday afternoon and Thursday morning. The annual "Get Acquainted Party" was held in the Elmira Aerie Home Wednesday Evening.

The State Aerie business sessions were held in the home of Elmira Aerie and the State Auxiliary sessions were conducted in the Holiday Inn - Downtown. The registration of delegates opened at 10:00 A.M. on Thursday, June 17th in the Elmira Club.

A Memorial Service was held in the Elmira Home at 7:00 P.M. Friday and the Joint State Convention Banquet on Saturday, June 19, in the ballroom of the Holiday Inn - Downtown.

### OFFICIAL OPENING OF THE CONVENTION

The convention was officially opened at 2:05 P.M. on Thursday, June 17, 1982, in the home of Elmira Aerie, By Elmira Aerie President Robert Butts. An overflow crowd of delegates and visitors from both the State Aerie and State Auxiliary filled the meeting hall to capacity. The ceremonies were opened with the presentation of the colors by the Elmira Auxiliary Drill Team. A salute was then given to the colors of both the United States and Canada and the audience was led in the singing of both national anthems by State Conductor Donald Rettinger of Toronto, Canada. The invocation was given by State President Wayne Monroe of Elmira Aerie. Elmira Auxiliary President, Marge Pooley, was then introduced and expressed her wish for a successful and productive convention. State President Wayne Monroe and Madam State President Sophie Hurwitz welcomed all delegates and visitors and expressed their appreciation for all of the assistance given throughout the year. The City of Elmira was represented by Mayor Mary Pat Ciccariello and Fire Chief Edward Hentz. Both spoke briefly welcoming all to the City of Elmira and expressing their best wishes for a fruitful and prosperous convention and also spoke on the points of interest in the area. Grand Auxiliary Trustee Carol Shay, Grand Aerie Trustee Jerry Wilson, of Anderson, Indiana, Grand Aerie Conductor Laverne "Shorty" Weber and Eastern Regional President William Carrick all spoke briefly on the accomplishments of the New York Jurisdiction and extending their greetings and best wishes for a successful convention. State President Wayne Monroe then introduced Past Grand Worthy President J.C. Mitchell, as the keynote speaker. Brother Mitchell gave an outstanding address of the principals of our fraternity and reminising his associations with the New York Fraternal Family. The joint session was brought to a close at 2:30 P.M. to make the necessary arrangements for the first business session.

**RULES OF THE CONVENTION:**

Credentials for admission: Properly accredited delegates and Past Worthy Presidents along with Ten Year Secretaries shall obtain their credentials from the proper committee upon presentation of official receipts showing that they are in good standing in their aerie.

No person shall be admitted to the main floor unless he is a delegate, Past Worthy President or Ten Year Secretary. He must display his credentials and deposit the daily attendance slip with the proper aerie officer. A visiting member in good standing, not a delegate, may attend the convention sessions, in a section set aside by the committee, as a spectator only.

A delegate desiring to be heard on any subject, which is properly before the Aerie, shall rise, give the salutation sign, address the Worthy President, state his name and number of his aerie. When recognized by the President he may proceed.

A question indefinitely postponed shall not again be considered, except by the action of two thirds of the delegates voting again to take up the matter.

Voting shall be by the voting sign of the Order, except upon Roll Call, then it shall be by aye and nay vote. Any thirty persons may demand a roll call on any question, but such demand shall be made before voting on the question.

Nominating speeches shall be limited to three minutes each and seconding speeches to two minutes each.

The election shall convene in the ante room adjoining the meeting hall on Saturday June 19, 1982 from 8 A.M. to 10 A.M. Only official ballots to be received. The count shall begin promptly at the close of the polls and continue to the completion thereof.

Delegates must present their credentials and ballots, depositing the latter in the ballot box. First ascertaining the number of votes indicated on the credential is identical with that indicated on the ballot and that no erasures appear thereon.

All resolutions must be reduced to writing, typewritten in triplicate if possible, and delivered to the State Secretary for distribution to the proper committees. The Committee on resolutions will, at the proper time, report all resolutions to the convention, with recommendations thereon.

Any part of the issue not covered by the rules of the convention or the rules of order shall be governed by Robert's Rules of Order Revised.

At this time it is customary to read the Order of Business for the convention, but in view of the fact there is no great change in the procedure, as regards to previous sessions and also that copies of the Order of Business have been distributed to all of the delegates, I shall dispense with the reading of the same, if there is no objection.

#### STATE SECRETARY'S REPORT

*Read by Acting State Secretary William Carrick, Middletown Aerie 544*

Brother Delegates:

For over a quarter of a century - 27 years to be exact, I have had the honor and privilege to give a brief resume of our various programs and what we have accomplished during the past 12 months. However, as in the past, the chairmen of the various State Committees will give a more detailed report in relation to their respective projects, as the convention progresses.

In the all important New Membership Program, because of the efforts expended by the State Membership Department and the local aerie producers, we closed out the fiscal year with 2,935 new members added to the roll. The brothers from the Province of Quebec added another new aerie to the State Eagle Family and did themselves real proud in securing new members in a campaign that will go down in our record books as a most successful one. Although we do have a number of so called "Weak Aeries" it is a pleasure to report that no local charters were revoked during the past year. At the present time, we have 57 units in the State jurisdiction. However, a request is now in the hands of the Grand Secretary to consolidate Mechanicville Aerie No. 3869 with Saratoga Springs Aerie No. 2586.

The official figures recently received from the Grand Secretary's office gives us credit for 15,462 members on the New York State-Eastern Canada tax list. This is an increase of 428 over last year's total. As in the past, a number of aeries did not report until after the survey was taken.

One of the major problems throughout the Country, and that goes for us too, is the sharp increase in the cost of all supplies and services. We are mighty proud of the fact there was no curtailment of any of our programs or services to the local aeries and have assisted in

every way possible to add to the success of their many projects with speakers, ritual teams, etc. The nice part is we did it within the budget. As of May 31, 1982, our balance stands at \$11,788.56. I certainly would be amiss if I didn't include the fact that our money figure would be a great deal lower if it weren't for the great majority of our leaders who continue to give so generously of their time and efforts without any remuneration whatsoever.

You will note, as the convention progresses, that our athletic programs are on the upswing. Bowling is still the tops, with the State Tournament and the Mr. and Mrs. event getting the biggest response, but the State Softball Program and the Annual Golf Party are both gaining as far as participation is concerned. The Horse Shoe Pitching fans are still in the talking stage.

At the Grand Aerie Convention held in Chicago, we can honestly say that New York "Swept the Boards" so to speak, with Laverne "Shorty" Weber being elected Grand Aerie Conductor, Carole Shay became a Grand Auxiliary Trustee, William "Bill" Carrick appointed Eastern Regional President and to add a little topping to the cake, the New York State Marchers were awarded first prize in the parade.

Reports received to date from our Humanitarian Funds show New York again well up on the generosity list and with a successful parade of Convention checks it is quite possible we will surpass the splendid amount contributed last year. Many times throughout the past year a number of grants have been presented to deserving institutions. There will also be special presentations made at the State Convention Banquet on Saturday evening. These were all made possible because of your continued support.

The State Fall Conference in Watertown and the Spring Conference in Oneonta were successful Eagle ventures. Highlights included the selection of Olean, N.Y. as the site of the 1983 State Convention. Laverne Weber was re-elected for another year as State Membership Director. The Mr. and Mrs. Bowling Tournament for 1982 went to the Lockport Aerie. The Softball Tourny will be held this Summer in Olean, N.Y., and the State Fall Conference will take place in Rochester, N.Y.

There is not a more satisfying feeling than a job well done. Under the leadership of State President Monroe and State Membership Director Laverne Weber, all of the State Leaders, the Committee workers, the individual producers, the unsung heroes who make things happen certainly made the State President's slogan, "We Can All Do It Together" become a reality.

In closing, I want to extend my personal thanks to the local aerie secretaries, the bulleting editors and all whose assistance made my job that much easier. A special thank you goes to my old sidekick of many years standing "Ye Olde Pickle" Ken Decker, our State Treasurer.

We have all the conditions necessary for a progressive 1982-1983. I feel sure that with all of us working together again, New York, under the leadership of Laverne Graham, will be another banner one for our Eagle Family.

Looking forward to a most successful convention and extending my very best wishes to all, for a safe trip home.

Rochester Aerie No. 52 sponsors Troop No. 452 which was started in 1975 with eight boys. At the present time there are forty five boys in the troop with over fifty five expected by fall. The Boys are always available to help with many aerie activities as well as community projects. Their camping record includes such awards as the National BSA Camping Award and National BSA Honor Unit Award. Two boys have attended Philmont Scout Ranch in New Mexico, three attended a council trip to Land Between the Lakes, Kentucky and one boy was a finalist in the BSA Public Speaking Contest Sponsored by Reader's Digest. The troop has had eight Eagle Scouts so far. The adult troop committee has averaged eight to twelve adults yearly, of which an average of fifty percent have been Aerie members.

We are pleased to announce that the Fire Hero Award, of New York State and Eastern Canada, will be presented to Captain Donald Harrison, of the Elmira Fire Department, by Horseheads Aerie No. 3818 and Elmira Aerie No. 941 at ceremonies to be held at a later date. In December of 1981, Captain Harrison dove repeatedly under the ice of a pond searching for the body of a nine year old boy. He was successful in finding the body and began mouth to mouth resuscitation while still in the water. There are over 500,000 Volunteer Firemen in New York State and Eastern Canada. There are about 100,00 Police Officers in the same governmental jurisdictions.

To select an individual as a recipient of the New York State and Eastern Canada Hero Award, a local aerie must submit the name to the State Aerie Secretary or to a member of this committee. Newspaper articles or clippings attesting to the heroics of the act must accompany the recommendation. The period covered is from January through December. The State Executive Board will act on all entries at the Spring Conference. Responsibility for presenting the award is left to the aerie making the recommendation.

The committee collectively reports at least sixteen instances of heroism in the State Jurisdiction and in each instance there was an Eagles Club within a matter of twenty or twenty five miles.

**REPORT OF THE SOCIAL SECURITY COMMITTEE**

*Read by Laverne Graham, Chr., Lockport Aerie No. 825*

Grand Aerie Representatives, State Officers and Brother Delegates:

As time goes on, more and more people become eligible for Social Security benefits. There are now over 36 million men, women and children receiving monthly benefits. This total includes about 2.9 million disabled workers and 2 million of their dependents. About 2.8 million children of deceased workers receive benefits and over 4.5 million older widows and widowers also receive Social Security benefits. Last year the payments out of the Social Security Fund totaled up to over 175.1 billion dollars in medical, disability and retirement benefits, making it the governments most successful social program.

There is less than one years benefits in the social trust fund. If these funds were to run a deficit, the treasury would be required to pay the benefits with its surplus tax revenues. Therefore, they are raising the maximum amount of the 1982 earnings to \$31,800.00 or 6.7 per cent. Also starting July 1st, the basic premium for medical insurance will go up \$1.20 a month. This will also be deducted from the Social Security check you receive in July,

With increases coming each year to keep up with increased earnings, congress is also in the process of raising the retirement age from 65 to 70 years of age to help bolster the trust fund and make it more solvent. Other changes that congress is proposing is to extend coverage to include, in the system, the estimated 6 million Federal, State and Local employees now exempt from Social Security. It would be years before many of them would start to draw on their benefits.

With medicare costs going up dramatically every year, and no relief is likely, predictions are that the Medicare Fund will run dry long before anything else. It is for this reason that Congressman John LaFalce has introduced a bill to shift funding for medicare and disability from the Social Security Payroll tax to general revenues. This would restore Social Security to its original purpose, a basic retirement system. By changing the financing behind medicare and disability, we can insure that the retirement fund is better protected and that medicare and disability funds are more efficiently operated.

The Social Security Administration recommends that you apply for direct deposit to your checking or savings account at your banking establishment. This is not only a time saving process for you but would save the Social Security System 65 million dollars a year.



Direct deposit will also help eliminate the possibility of theft or lost checks. To arrange for direct deposit, go to your financial organization and fill out form S.F.-1199.

We believe social security to be a very important part of all our lives and our future. Although there have been recent increases in Social Security Benefits, the increases have not kept up with the rising cost of living.

This committee recommends that every aerie discuss the proposed changes with its members and write your congressmen and senators to support these changes and make the Social Security system worthwhile so all will be able to benefit by it when we reach retirement age.

### REPORT OF THE STATE MEMBERSHIP DIRECTOR

Read by *Laverne Weber, State Membership Director, Lockport Aerie No. 825*

Every effort was made this year to make the 3000 member goal set by State President Wayne Monroe at the start of the year. However, the overall total of 2,935 new members, reported as of May 31st, left us just 65 members short. You all did an outstanding job and my sincere thanks and appreciation for a job well done.

At our membership meeting last June the following State wide campaigns were established. June, July and August - The Early Bird Campaign - gave us a good start when 452 new members were reported. September was set aside to honor our State Secretary and was known as the "AL LANE" Campaign and 251 members were reported. Plaques were presented to Rochester Aerie No. 52 for reporting the most members and to Lansingburgh Aerie No. 3773 with a percentage gain of 7.7 percent. We also had a contest with the State of Massachusetts, on a percentage basis, during September. However, we lost by just a small margin. During October, November and December a contest was held between the Zones and known as the Football Campaign which produced 689 new members. Zone 1 accumulated 96.92 points to become the winning zone and the Harry Woodruff Traveling Plaque went to Lockport Aerie No. 825 with a percentage gain of 18.9 percent. The Hunters Campaign was held during the month of November and both the Hunter's Trophy and the percentage gain trophy were captured by Lockport Aerie No. 825 for reporting 108 new members. January, again, was set aside for the State Presidents Campaign and another 259 members were added to our rolls. The State Presidents Trophy was won by Montreal Aerie No. 2130 and the Membership Trophy went to Villa LaSalle Aerie No. 3976 with a percentage gain of 15.0 percent. Although the State of Massachusetts, reported only 137 new members during our second contest with them, they did defeat us by 2 percentage points. February gave us the Police and Firemen Campaign and our membership was increased by a big 275. Lockport Aerie No. 825, with 61 members, reported, became the winner of the Membership Plaque and Schenectady Aerie No. 514 took the percentage gain plaque. What a success the Under Thirty Five Campaign was by adding 388 new members. Lockport Aerie No. 825 reported 54 new members and took the Top Producer Plaque and Mont-Laurier Aerie No. 3993 was winner of the percentage gain

plaque. Montreal North Aerie No. 3899 captured the Al Lane Traveling Trophy in April by reporting a percentage gain of 42.8 percent. Finishing the year with the State Membership Directors Campaign gave us another 302 new members for a grand total of 2935. Mont-Laurier Aerie No. 3993, our baby aerie, took all honors and won both the State Membership and the percentage gain plaques.

Each month a small plaque was presented to the aerie reporting the greatest number of new members. The top monthly producers are as follows: June - St. Jerome Aerie No. 3176 reporting 56; July - Rotterdam Aerie No. 3610 reporting 18; August - Hornell Aerie No. 2640 reporting 14; September - Rochester Aerie No. 52 reporting 25; October - Rochester Aerie No. 52 reporting 20; November - Lockport Aerie No. 825 reporting 108; December - Lockport Aerie No. 825 reporting 34; January - Montreal Aerie No. 2130 reporting 54; February - Lockport Aerie No. 825 reporting 61; March - Lockport Aerie No. 825 reporting 54; April - Lockport Aerie No. 825 reporting 68; May - Mont-Laurier Aerie No. 3993 reporting 30. Lockport Aerie No. 825 became membership champ for the year and captured the State Membership Trophy by reporting 394 new members followed by 2 - Rochester Aerie No. 52 reporting 222; 3 - St. Jerome Aerie No. 3176 with 135; 4 - Elmira Aerie No. 941 with 125 and 5 - Schenectady Aerie No. 514 reporting 125.
